Motion: Mr. Flaherty made a motion to accept the TPA's donation of \$3,090.28. Mr. Peterson second. All in Favor. The motion was passed unanimously

SCHOOL COMMITTEE CHAIR REPORT

Massachusetts Education Partnerships Presentation

Nancy Peace, Executive Director, Massachusetts Education Partnership, gave a presentation to the School Committee on interest-based bargaining in the collective bargaining context.

King Philip DECA Project

Motion: Mr. Flaherty made a motion to allow the DECA students from King Philip to send flyers home for the collection of items needed for our soldiers who are overseas. Second by Mr. Doyle. All in Favor. The motion was passed unanimously.

Regional School Committee Chair's Meeting

Mr. Dooley spoke to the committee about his recent meeting with the Wrentham and Plainville School Committee Chairs. One topic of discussion was to ensure that our curriculums are coordinated with the common goal of our children entering the middle school. There is much anticipation for the next meeting with possibly a joint school committee meeting/round table/retreat to discuss general issues.

SUPERINTENDENT REPORT

Norfolk Public Schools Partner Application – Boston College

Lisa Altham-Hickey, Principal of the Freeman-Kennedy, and Cheryl Lassey, Adjustment Counselor at Freeman-Kennedy, brought this application to the Committee. The friendship project entails Dr. MacEvoy, Assistant Professor at Boston College, collecting data from students 3 times during the academic year. The results of the project will be shared with faculty, along with resources and materials for supporting students in developing and maintaining friendships.

Motion: Mr. Flaherty made a motion to accept Boston College's application for school partnership. Second by Thomas Doyle. Three Committee members in favor. Mr. Flaherty opposed. The motion was passed.

At 7:55pm The Committee took a five-minute recess.

At 8:00pm the Committee resumed the meeting.

Neighboring Districts Use of Facilities Fees

Dr. Allardi presented to the committee the building use/rental costs from neighboring communities. Dr. Allardi recommended to the School Committee that a \$20.00 hourly rental fee be charged for use of the gymnasium for non-school partners. Dr. Allardi will update the fee schedule and report back to the Committee at the next meeting.

Norfolk Public Schools Family Handbook

Motion: Mr. Flaherty made a motion to accept the Norfolk Public Schools Handbook. Second by Mr. Doyle. All in favor. The motion was passed.

Emergency Planning

Dr. Allardi spoke about the recent Professional Development Day. All staff, teachers and substitutes practiced several scenarios on how to respond to a live shooter in the building. At the end of the training, everyone felt empowered and prepared. Members from King Philip, Wrentham and Plainville were invited to attend. Local police will follow-up and answer questions at the next staff meeting.
