### MINUTES School Committee Meeting Wednesday, August 4, 2010 Norfolk Town Hall – Room 124

**Present:** John Olivieri, Ross Gilleland, Linda Andrews, Thomas Doyle and Shawn Dooley

Also present: Dr. Claire Jackson, members of the community and staff

Shawn Dooley, Chair, called the meeting to order at 7:10 pm.

# **PUBLIC COMMENT**

David Pimental, 76 Boardman Street, asked the School Committee about the outcome of the Ad Hoc Committee's deliberations regarding the access road.

### ADMINISTRATIVE/REGULAR ITEMS

Announcements:

Mr. Olivieri inquired about the new House Bill 4935 related to insurance coverage for students with autism that will become effective on 1/1/11. Dr. Jackson agreed to provide information to the Committee as it becomes available.

# SCHOOL COMMITTEE CHAIR REPORT

<u>Bicentennial Park</u> Mr. Dooley, Chair, discussed the conclusion of the research done by the town counsel regarding the ownership of the Bicentennial Park. According to town Counsel, the school department owns the land.

Mr. Dooley proposed that the School Committee vote to reclaim the land for potential use for the new school building project. He recommended making the decision before August 15th when the final bids are completed. The School Committee may use the land for purposes of a school building site. Mr. Gilleland commented that there are currently not enough reasons to use this land for an access road and the NSBC and Ad Hoc Committee will be making a recommendation.

**MOTION:** Mr. Doyle made a motion that the School Committee vote to reinforce the understanding that the School Committee has the care, custody, and control of Bicentennial Park as school property as outlined in Exhibit 1, the written opinion by George Hall, Town Counsel. Mr. Gilleland seconded. 4 in favor. 1 opposed. **The motion passed**.

### Superintendent Search

Dr. Jackson suggested that the School Committee members conduct their own search to save \$8500. She has recommended a timeline to begin November 15th and ending in March. She distributed a draft advertisement and cost for advertising. Since most candidates will look on MASC, MASS and SchoolSpring.com websites and we are mailing a brochure to over 700 candidates though MASC, the School Committee agreed to advertise only in the Boston Globe. Mr. Dooley would like the School Committee to review and assist with recommendations for membership on the search committee. Community members who are interested in serving on the committee were asked to contact the school committee. A Connect-Ed message will be sent to the Norfolk families and King Philip families asking for volunteers for this committee.

# **Common Core Standards**

Dr. Jackson introduced the Common Core Standards, a common core of curriculum that has been adopted by over 25 states. These standards will help transient students understand the curriculum. Massachusetts has adopted the Standards and will begin to incorporate them as existing frameworks disappear. Common Core Standards will help us begin the work of developing our curriculum expectations.

David Pimental, Boardman Street and David Moore, 61 Boardman Street Are in favor of the access road for safety reasons.

**MOTION:** Mr. Gilleland made a motion to adjourn to Executive Session for the purpose of discussing strategies for collective bargaining and review of current teacher contract not return to return to regular session. Mr. Doyle seconded. **The motion**
