The Norfolk Recreation Playground Program is a supervised, drop-off program held at the Pond Street Recreational Complex.

2012 DATES: MONDAY JULY 9TH - WEDNESDAY, AUG. 15TH.

Monday - Thursday 9:00am-1:00pm, weather permitting.

Join us for fun, organized and supervised games and activities each day! There will be daily crafts projects, facilitated sports activities such as kickball and dodge ball, and games such as Capture the Flag as well as playground time. On hotter days, water games may be played at the end of the day. Playground "standards" such as gimp are available everyday. Look for theme days which will be posted ahead of time. Children may arrive and depart at any time with a parent or authorized individual to sign the child in and out. If children are entering grades 5-6 this fall, they may ride their bike with permission. Bikers must also sign in and out. The program is staffed with 7-9 experienced counselors each day.

REGISTRATION FEE: On or before June 11: \$12. June 12 or after: \$20.

PLUS DAILY FEE: \$1 per day, or \$20 in advance when you register.

Please consider paying the \$20 for the summer – these fees go directly to the playground and help us cover expenses. The Playground Program relies solely on your fees, donations and grants. No tax dollars pay for any of our programs. Please keep in mind we will not be able to issue refunds for this program including for weather cancellations. All money collected will go directly to the playground program for supplies and staffing.

TO REGISTER: Registration is Walk-in or Mail-in only, no on-line registration is available for this program. Please bring or mail a completed Playground Enrollment form (attached) to the Recreation office. Walk-in Location: Ground floor of the Town Hall. Mail-in address: Norfolk Recreation, P.O. Box 282, Norfolk, MA 02056.

Your registration fee includes a t-shirt for tie-dying at Playground.

IMPORTANT: Please note t-shirt size on registration form. If in doubt of size, please order a size larger. First round of T-shirts are being ordered June 12 and children will receive them the first day they attend the Playground.

Location: This year's Playground Program is being held at the Pond Street Complex. This is an outdoor program. Please send children with plenty to drink and at least one healthy snack.

Please mark all belongings boldly-including food and water bottles! Children will need to be picked up if it is raining or it becomes excessively hot (93° or above and/or extreme humidity).
