- Students must bring a valid photo-ID to both the pretest session and the April 19 ACT test session. Acceptable photo-ID includes any state, federal or school issued ID in hard plastic card format. The photo-ID must include the examinee's first and last names, and the photo must be recognizable as the examinee.

- 11<sup>th</sup> Grade Status – Examinees must also show proof of 11<sup>th</sup> grade status. Appropriate proof of 11<sup>th</sup> grade status may include the most recent report card or transcripts. Homeschooled students may be verified by the parent.
- Photo ID – When returning this form, please bring the photo-ID the examinee intends to use for both the pretest and April 19 ACT test session.
