June 7, 2018

The Oneida Special School District Board of Education met in regular session on Thursday, June 7, 2018, at 6:00 p.m. in the Central Office Conference Room. The following members were present: Dr. Danny Cross, Mrs. Dorothy Watson, Mr. Brom Shoemaker, Mr. Mark Matthews and Dr. Nancy Williamson. Also in attendance were Director Jeanny Hatfield and Lori Marcum, Secretary.

Chairperson Williamson called the meeting to order. The board led those in attendance in the pledge of allegiance.

Chairperson Williamson presented the board agenda with two additions for consideration. The additions were one (1) fundraiser from the OHS girls basketball team and a letter of resignation from Mrs. Kelly Scoggins. The additions would be added to the agenda as Item 5C for the fundraiser and Item 19 letter of resignation. Dr. Cross made a motion, with a second by Mr. Shoemaker to approve the board agenda as amended. Vote was taken and motion carried.

Chairperson Williamson then presented the consent agenda for board approval. Mrs. Watson made a motion, with a second by Mr. Matthews, to approve the consent agenda as follows. Vote was taken and motion carried.

Under business before the board, Chairperson Williamson presented the Coordinated School Health Continuation Application for board approval. Mr. Shoemaker made a motion, with a second by Dr. Cross, to approve the application. Vote was taken and motion carried.

Chairperson Williamson then presented the ALQI Grant Agreement for board consideration. It was noted the agreement was the standard yearly agreement between the district and ALQI. Chairperson Williamson then presented the E-PLAN Consolidated Application EESA, IDEA and CTE. After a brief discussion, Mr. Shoemaker made a motion, with a second by Mr. Matthews, to approve E-PLAN. Vote was taken and motion carried.

RESOLUTION

TO ADOPT A CONTINUING BUDGET

FOR FISCAL YEAR BEGINNING JULY 1, 2018
TO AUTHORIZE THE EXPENDITURE OF FUNDS BY
THE VARIOUS OFFICES OF THE SCHOOL DISTRICT

WHEREAS, it now appears that fiscal year 2017-2018 budget for the Oneida Special School District, will not be approved by July 1, 2018.

NOW, THEREFORE BE IT RESOLVED, by the Legislative Body of the Oneida Special School District, Oneida, Tennessee, meeting in regular session, on this the 7th day of June, 2018, that:

SECTION 1. The amounts set out in the fiscal year 2017-2018 Appropriations Resolution are continued and the various departments and offices are authorized to expend funds at the same level as the previous fiscal year.

SECTION 2. No local funds can be expended or obligated that exceed the previous year's budget appropriation until a new budget is adopted. Expenditures mandated by the State or rules and regulations adopted by the State are incorporated into this continuing budget.

SECTION 3. This resolution will take effect from and after its passage and its provisions will be in force from July 1, 2018, until the budget for fiscal year 2018-2019 is finally adopted and approved. The Secretary shall include this resolution in the minutes of the Oneida Special School District Legislative Body and send a copy to the State of Tennessee.

Coordinated School Health and Family Resource

May 2018 Board Report

April 11-13 Oneida CSH Health presented at the Coordinated School Health Institute about Oneida's Fresh Fruit and Vegetable Program.

On April 20th Coordinated School Health, Tennessee Department of Health, and Oneida School Nurse provided hygiene, puberty and Opioid/drug abstinence education for all middle school students. Family Resource and CHAMPS provided hygiene items for all students at Oneida Middle School.

Coordinated School Health Provided SPARKE curriculum Kits for wellness instructors of grades 3-9. Training will follow in July.

Oneida Coordinated School Health presented Oneida Schools' Project Diabetes initiative to the Tennessee Department of Health on May 9, 2018. This project has enabled the Oneida Special School District to obtain additional sixty thousand dollars (\$60,000) in funding for nutrition, physical activity, and community initiatives for student wellness. This project helped to construct the new walking trail, provided fresh fruits and vegetables weekly for students while obtaining other funding for STEM and action based learning.

April 20 was Health Focus Day for all Oneida Middle School Students. Topics such as hygiene, teen development, healthy relationships, and Opioids/ drug use dangers were used. Thank you to CHAMPS and Family Resource for providing hygiene goody bags for all Oneida Middle Students.

On April 29th – May 2, Oneida Coordinated School Health attended the Blueprints for Learning Conference. Conference themes focused on Violence and Drug use prevention as well as social emotional learning components for students and communities.

Two hundred twenty-nine (229) students were screened for Oneida Sports Physicals on May 10, 2018. A special THANK YOU goes out to MPHCI. Breakfast and Lunch for health screening staff was provided by OES, OMS, OHS, and School Health.

Coordinated School Health Coordinator attended Safety Site Assessment Training for the district on May 24, 2018. Training was hosted in Campbell County by Sargent Martin who focused on enhancing physical security of all buildings through the evaluation of environmental designs of the campus. This training is required in order for districts to receive the additional safety funding that will be distributed by SAVE Act of Tennessee.

Staff Wellness News

Ms. Beth Armstrong won Biggest Loser this year, while Shawn West took the top award for Skinny Pig! Both winners received an Apple iWatch, gift cards from Walgreens, and a car wash package from TNT Car Wash. Shawn West also took home Petunia Pig and \$73.00 in cash.

This year Oneida Special School District wellness competitions consisted of four (4) staff walking teams! This year's WINNING TEAM accumulated over 3,600 MILES!
