The Oneida Special School District Board of Education met in regular session on Thursday, May 4, 2017, at 6:00 p.m. in the Central Office Conference Room. The following members were present: Dr. Danny Cross, Mrs. Dorothy Watson, Mr. Brom Shoemaker, Mr. Mark Matthews and Dr. Nancy Williamson. Also in attendance were Director Jeanny Hatfield and Lori Marcum, Secretary.

Chairperson Williamson called the meeting to order. Cal Smith led those in attendance in the pledge of allegiance.

Chairperson Williamson acknowledged Mr. Trent Coffey from STAND. STAND along with the Scott County Chamber of Commerce are once again this year recognizing an outstanding senior student nominated by the OHS staff who exemplifies character and citizenship. The April student of the month was Mr. Cal Smith. The May student of the month was Ms. Baylee Thomas. It was also noted that Elizabeth Campbell was the January student of the month. Mr. Coffey also announced that the monthly winners were drawn for a \$500 scholarship and this year's Student of the Year and scholarship winner was Mr. Grant Marcum.

Topics that were discussed included whether schools should offer at least 20% of their curriculum online.

Chairperson Williamson then presented a letter of retirement from Mrs. Teresa Sexton for board approval. Mr. Shoemaker made a motion, with a second by Mr. Matthews, to approve the retirement as presented. Vote was taken and motion carried.

Chairperson Williamson then presented network bids for board approval. It was noted that ENA had won the bid, however, the project would be based on ERATE funding. Mr. Shoemaker made a motion, with a second by Mr. Matthews to approve the network bids as presented. Vote was taken and motion carried.
