The Oneida Special School District Board of Education met in regular session on Thursday, November 8, 2018, at 6:00 p.m. in the Central Office Conference Room. The following members were present: Dr. Danny Cross, Mrs. Dorothy Watson, Mrs. Sandy Martin, Mr. Jason Perry and Dr. Nancy Williamson. Also in attendance were Director Jeanny Hatfield, Student Representative Christian Blakeley and Lori Marcum, Secretary.

Chairperson Williamson called the meeting to order. Kinley and Karsyn Billingsley led those in attendance in the pledge of allegiance.

Chairperson Williamson recognized Mrs. Faye Heatherly for a presentation. Mrs. Heatherly, the immediate past president of TSBA, presented with board with The Board of Distinction award from TSBA.
