November 9, 2017

The Oneida Special School District Board of Education met in regular session on Thursday, November 9, 2017, at 6:00 p.m. in the Oneida High School Library. The following members were present: Dr. Danny Cross, Mrs. Dorothy Watson, Mr. Brom Shoemaker, Mr. Mark Matthews and Dr. Nancy Williamson. Also in attendance were Director Jeanny Hatfield, Student Representative Mattie Scoggins and Lori Marcum, Secretary.

Chairperson Williamson called the meeting to order. Quintin Cruz and Rebekah Cruz led those in attendance in the pledge of allegiance.

Chairperson Williamson called for the student of the month presentation. STAND and the Scott County Chamber of Commerce are once again this year recognizing an outstanding senior student nominated by the OHS staff who exemplifies character and citizenship. The October student of the month was Ms. Carrington Lay.

Mr. Trent Coffey with STAND also invited the board to the 2nd Annual Town Hall Meeting.

Chairperson Williamson then recognized Mr. John Dwyer from Jobs for Tennessee Graduates. Mr. Dwyer thanked the board and Dr. Hatfield for their participation in the program. Jobs for Tennessee Grads offers seniors with barriers to graduation, any barrier to graduation, leadership skills, interview skills, as well as scholarship and application assistance. Mr. Dwyer stated that the program offers those “soft skills” students will need in the future to become employable productive citizens.

Physical Activity

- Read -N-Ride Grant for OES was awarded to Oneida Coordinated for the implementation of a stationary bike classroom for students. The classroom will inspire students to read while they use stationary bikes.
- The total of GoNoodle minutes for the last term was over 61,000 minutes! The next GoNoodle Classroom winners will be announced December 15th, 2017!

School Health Education

- Oneida CSH awarded \$1000.00 in prizes for students during drug and tobacco week for student and classroom incentives. **THE OVERALL WINNER** in the building was Ms. Leslie Pemberton. She wins a **DAY OFF**. Over 35 murals competed in this year's contest and a first and a second place winner was chosen from each pod. Special thanks to Mrs. Sims at OES and the following judges: Patty Swain, Amy Lane Duncan, Sabra Cope, Brad Chambers, Katie Garrett, and Kathy West.
- The Scott County Health Department and The Children's Center provided tobacco and drug education to students this month for Drug and Tobacco awareness week.
- Professional development will be held on November 15, 2017 in the Fines Arts Center of Oneida High School. Ms. Pat Conner and Ms. Kim Daubenspeck will be presenting information to certified staff about Adverse Childhood Experiences

School Safety

- AED drills were administered for all buildings this month: OES responded in 14 seconds, OMS /OHS responded in 11 seconds. CPR was started within an average of 32 seconds, while the AED was started in no less than 2.5 minutes for all buildings.

- All Hazards Plans for 2017- 2018 school year are updated and being distributed to Emergency Response Personnel.

Health Services

- The school nurse, Marilyn Seabolt, saw 706 students in the clinic this month of October and sent home 29.
- SCHD completed Flu shots for student by October 27th. The Health department reports a better than average participation rate for both OES and OMS. (Total 155 students)
- Free Dental Sealants, provided by Knoxville Regional Health will be completed at Oneida Elementary by Thanksgiving Break. Knox Regional Health has sealed over 985 teeth, provided fluoride treatments as well as dental education. The in-kind amount for these services is: \$34,475.00.
- November 16th, 2017 will be the make-up date for School Health Screenings for those students who were absent or need vision rescreen.

Family Resource Center:

- The Oneida Family resource Center provided over 130 food backpack bags for the month of October. Hygiene, clothing school supplies and shoes were also provided for children of our families within the school district.
- Ms. Overton's Class made "treat bags" for senior citizens in the community.
- Ms. Patty West's Food and Consumer Science class provided Thanksgiving Food Baskets for 26 needy families from the Family Resource Center. Food basket were delivered or received November 8, 2017.
