The Oneida Special School District Board of Education met in regular session on Thursday, October 4, 2018, at 6:00 p.m. in the Central Office Conference Room. The following members were present: Dr. Danny Cross, Mrs. Dorothy Watson, Mrs. Sandy Martin, Mr. Jason Perry and Dr. Nancy Williamson. Also in attendance were Director Jeanny Hatfield, Student Representative Christian Blakeley and Lori Marcum, Secretary.

Chairperson Williamson called the meeting to order. The board led those in attendance in the pledge of allegiance.

- School Health Screens went smoothly on September 21 and September 28. A big THANKS to Pioneer Medical Hospital and ALQI. Reports to parents will be sent home November 2018.
- Asthma and Allergy Screens were offered to all 4th and 7th grade students during this month's health screens. Reports went home to parents on Monday, October 1, 2018.
- CSH Coordinator presented education to all high school students this month about Vaping, Juuling, and the dangers of E-cigarette use.
- OHS/OMS recognized blue, gray, and purple day on September 28 as part of the Suicide Awareness Initiative.

- Oneida CSH will be presenting at the LEAD Conference in Nashville. The presentation highlights the school based mental health program within the Oneida District.
- Oneida Schools celebrated a new physical activity and nutrition kick off from FUEL UP TO PLAY 60!! Oneida is the **first** district to receive funding for all schools. The grant provides more than \$12,000 in supplies to improve nutrition and exercise.
- Mountain Peoples Health Council will administer flu vaccinations for staff on October 4. The Scott County Health Department will administer FREE flu vaccinations to all students on October 3 and October 5.
- School Health and Family Resource Advisory Council will meet at the Family Resource Center on October 19 at noon! Lunch will be provided and all board members are invited to attend.
