OCS Goal # 1: Onslow County students will be globally competitive through the mastery of a rigorous and relevant curriculum.

Strategy: Ensure a consistent school focus at high levels through the support and leadership of school administration, faculty, and staff.

- enVisions Math by Pearson/Scott Foresman was utilized in all grade levels
 - electronic components
 - o student manipulative kits
- Fifth grade classrooms were self-contained for the 2009-2010 school year.
- Math and Science was emphasized during the AIG Fair
- Accelerated Math was implemented in Second Grade classrooms
- Benchmark assessments were administered to all at-risk children
- At-risk students in grades 3 5 were tutored after school using funds gained from the Weed and Seed Grant from the City of Jacksonville
- Staff members received training on the EVASS system
- Staff development was provided on mathematics
- Staff development on guided reading and small group instruction was provided to all teachers
- Promethean lessons were utilized during mathematics instruction
- Discussions regarding PLC's were initiated
- Staff were trained on developing and maintaining PEP's
- The Instructional Support Teacher was utilized to assist with IEP compliance and delivery

OCS Goal #2 Onslow County schools and students will be led by creative, passionate, and technologically skilled professionals.

Strategy: Create and foster a workplace that attracts and retains highly quality professionals; communicate and foster a climate of high expectations for employee performance.

- Clubs were implemented for third grade
- Teachers had a minimal of one Promethean lesson a month, as indicated in lesson plans
- Teachers in grades 1 3 took advantage of duty-free lunch. Teachers in grades K, 4, and 5 opted not to have a
 duty free lunch.
- Teachers submitted their lesson plans electronically
- Teachers maintained their class web page

Strategy: Develop, monitor, and adhere to the "Safe and Civil Schools Series" which emphasizes school-wide behavior management plans, all safe schools' criteria and healthy child legislation.

- New morning duties were established to provide more adult supervision across the campus
- Staff members were provided with an updated copy of the school-wide discipline plan
- Staff were trained on expectations for office referrals and levels of discipline
- Nine week behavior parties were expanded to reward positive student behavior
- A recycling program for milk cartons was established

<u>2005 – 2010 Strategic Plan</u>

Bell Fork Elementary's 2005 – 2010 Strategic Plan was very successful. Students have shown academic growth and teachers have grown professionally. School safety has increased and parental involvement is on the rise. The school would like to continue to work on implementing inquiry-based science lessons, as well as utilizing manipulatives during mathematics instruction in all grades during the next planning cycle.
