Principal's Message

Welcome to Northwoods Park Middle School! The school's planning team and other stakeholders have spent much time disaggregating data and considering our strengths and challenges as it relates to school improvement. This collaborative work has been instrumental in designing a strategic plan that will enhance our programs, services, and processes leading to ever-improving educational and operational processes. We continue to face challenges of stringent standards presented by the NC State Board of Education and federal regulations.

Our plan is designed to inform stakeholders of our response to the results of data analysis of student performance, staff input and from legislative requirements and local school system initiatives. Strategies and activities in the plan are intended to ensure we are meeting the diverse needs of our students to impact their learning not only while they attend Northwoods Park Middle School, but to prepare them for the challenges of high school and post-secondary endeavors. Our district has committed to providing 1:1 technology for Onslow County's students and our seventh and eighth graders were among the first to receive 1:1 laptops in 2014-2015. The 1:1 Initiative continues in 2015-2016.

We will build upon our accomplishments and learn from our results as we provide rigorous, relevant, and engaging classroom instruction in an environment where positive relationships with our students, parents, and community are highly valued.

We will continue to provide a caring and safe environment where all students have the opportunity to learn at high levels of engagement with a focus on the skills necessary to be successful in high school and beyond. Our committed staff utilizes the Professional Learning Community model to work collaboratively to ensure that the individual and diverse needs of students are met through an academically rigorous and differentiated instructional program.

Overall, we are proud of the continued efforts of our students and staff. We continue to assess our progress to meet the needs of all students regardless of background or achievement levels. Introduction

This profile provides pertinent information needed to develop a strategic plan for continuous improvement, to assist our school, district, and state in monitoring the organizational and instructional effectiveness and success in meeting student needs. The profile also documents a description of programs and services, a summary of the major trends or issues impacting the school and a summary of major strengths and challenges for the school. While this profile provides the school system and stakeholders with information needed to develop a strategic plan for continuous improvement, a more in-depth and detailed analysis of the data is made annually, both at the system level and the school level, to assist the system in monitoring the organizational and instructional effectiveness and success in meeting student needs.

Demographic Data

Northwoods Park Middle School is nestled in the heart of the Northwoods community in Jacksonville, NC. Northwoods Park Middle School has a strong instructional team of energetic teachers and support staff who are focused on the task of continuous school improvement. At this time, the staff's demographic composition of 22% black, Hispanic non-white, Asian, and multi-racial does not reflect our student demographic composition of 71% black, Hispanic non-white, Asian, and multi-racial. In addition, 50% of our students are Economically Disadvantaged (receiving free or reduced lunch). The disproportionate structure in our demographics creates a cultural disparity requiring high levels of transparency to increase staff awareness and understanding of all students, their individual experiences, and their personal learning needs to enable success for every student.

The students of Northwoods Park Middle School are residents of various neighborhoods within the Jacksonville city limits. Jacksonville is the commercial hub of Onslow County and the tenth largest city in NC with a population of over 70,000. It is the home to Marine Corps Base Camp Lejeune and the Marine Corps Air Station New River. For this reason, our community is comprised of people of various cultural and ethnic backgrounds as well as very transient. Approximately 39% of students enrolled at Northwoods Park Middle School have a military connection either through uniformed services or civil service positions. A dominating influence impacting transient student and staff population of Onslow County is the Marine Corps Base Camp Lejeune, the largest amphibious training military base in the world.

Data Analysis

Student performance for three consecutive years decreased from -2.0 growth in 2012-13 to -10.06 in 2014-15. This steady decline resulted in an analysis of subgroups not meeting AMO targets for all three years, while taking into consideration a reconfiguration of student proficiency scores for state assessments to include five levels of performance (CCR) in 2013-14 from the previous four levels (GLP) in 2012-13.

In 2013-14 and 2014-15, the following subgroups did not meet Reading targets: black, multi, white, EDS, and AIG. In the same two years, the following subgroups did not meet Math targets: black, multi, white, EDS, SWD, and AIG. In 2014-15, the following subgroup did not meet Science Grade 8 targets: black. This low performance of black students correlates to 60% or more of all ISS/OSS disciplinary actions involved black male and female students. In 2014-15, the infractions leading to ISS/OSS primarily comprised of three types of infractions: technology misuse (also the first year of the 1:1 initiative for seventh and eighth graders), disrespect to staff, and disruption in the classroom. In response to these prevalent behavior infractions, the NWPMS staff began revising components of PBIS and behavioral expectations as well as expanding non-academic opportunities for mentoring and advocacy through the programs available to students, such as EMBODI, STRIDE, and Heart and Soles.

Mentoring and advocacy programs address only one aspect of students' needs. With the complete restructuring of the NWPMS master schedule for 2015-16 to increase instructional time and decrease transition time leading to lost instructional time for all grade levels, all three grade levels have 50 minutes of Enrichment on an A/B flexible schedule. During this time, teachers are using Common Formative Assessments (CFA) to inform their instruction, as well as providing extension lessons for AIG students to dig deeper into the curriculum or engage in re-teaching strategies to small student groups.

In Professional Learning Communities, core content teachers analyze CFA and benchmark data to identify trends in grade level performance to inform instructional planning in the core classes and during Enrichment. The PLC's are facilitated by the school's Instructional Coach whose primary responsibility is to assist teachers in analyzing assessment data and identify strategies for enrichment or remediation.

With a steady decline in student performance on Reading Grades 6-8, the staff recognized a need to improve literacy instruction to increase reading fluency coupled with critical vocabulary comprehension. All teachers are being trained in AVID Critical Reading strategies as well as incorporating grade specific critical vocabulary in all subjects to include encores.

Low student performance in math resulted in a collaborative Onslow County Schools middle grades professional development plan for 2015-16 to analyze data, identify research based AVID best practices, and learn from other teachers who have met or exceeded expectations for student performance in three consecutive years. Again, CFA's and re-teaching concepts based upon individual student performance to create a personalized plan for student success provides the foundation for the work teachers are doing to address student performance in Math Grades 6-8.

Programs/Services

In addition to its core instructional program, Northwoods Park Middle also incorporates specialized programs and services to meet the varied educational needs, expectations and learning requirements of all learners, *including the following:*

- **Academically/Intellectually Gifted Program:** offers differentiated instructional services and support to those students identified.
- **Academic Derby:** students are selected to compete with other middle school students in the county in answering trivia type questions related to various topics.
- **AVID (Advancement Via Individual Determination):** gives students support and sets higher expectations that students need to succeed and prepare for postsecondary opportunities by pushing them into more rigorous coursework.
- **Arts Program (art, dance, music and drama):** students participate in classes that develop and support creativity, collaboration, confidence, problem-solving, receiving constructive feedback, dedication and accountability.
- **Career and Technical Education Programs:** opportunities are provided for students to explore business and computer technology to support lifelong learning.
- **CHEW:** Children Healthy Eating on the Weekend is a collaboration with the Onslow County United Way. Through its backpack program, CHEW provides kid-friendly, easy-to-prepare food for the weekend (and over long breaks) to students from food-insecure homes.
- **Dolphin Diplomats (Student 2 Student):** student-led, school-managed program that confronts the challenges of transition and provides relevant training to enable success at the middle school level.
- **Dolphin EMBODI:** Empowering Males to Build Opportunities for Developing Independence is an outreach youth program with a designed curriculum to build on academic enrichment, personal development and wellness, career development, cultural development and family involvement. This program will be supported by the local Delta Sigma Theta Sorority Inc. in collaboration with school reform efforts.
- **Enrichment:** provides opportunities for students to maximize learning and productivity while receiving targeted support from teachers and peers.
- **Exceptional Children's Program:** offers individualized education and related services to identified students.
- **Extracurricular Programs:** provide additional opportunities for students to participate in during school and after school clubs, student organizations, service organizations, athletics, focus intervention and other educational experiences, such as FCA, Robotics, Math Counts, Academic Derby, Battle of the Books, and various sports.
- **Heart and Soles:** middle school girls meet twice weekly to develop skills to support nutrition and fitness, goal setting, communication skills, teamwork and character development. A 5k race concludes the end of school year.

- **National Junior Honor Society:** recognizes eligible seventh and eighth grade students based on scholarship, service and citizenship. NJHS students participate in service learning projects throughout the year.
- **PBIS (Positive Behavior Instructional Support):** PBIS is a proactive systems approach to establishing the behavioral supports and social culture and needed for all students in a school to achieve social, emotional, and academic success.
- **Professional Development:** relevant professional development designed to target challenges as noted in data analysis. A focus on Curriculum, Instruction and Assessment, Differentiated Instruction and full implementation of AVID strategies in all classrooms.
- **Professional Learning Communities:** all grade levels participate in data analysis and designing lessons to meet students' needs and close achievement gaps.
- **Robotics:** students compete against other middle schools across the state/country in the areas of programming and robotics
- **School-wide Literacy:** literacy lessons are created by the Instructional Coach and taught to all students by encore staff during early release professional development (ERPD) days.
- **Science Fair:** sixth and seventh grade students compete within the school and within the district for the opportunity to showcase science inquiry.
- **STRIDE:** sixth grade boys meet twice weekly to develop skills to support nutrition and fitness, goal setting, communication skills, teamwork and character development. A 5k race concludes the end of school year.
- **Yearbook:** sixth and seventh grade students use journalism, photography, desktop publishing, artistic design, and marketing skills as they collaborate to design and publish the annual yearbook.
