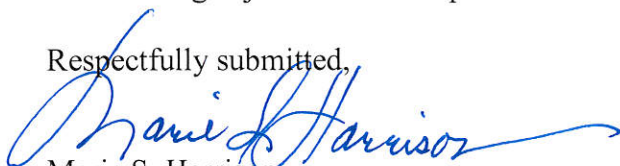
Vernell Goodwin noted an item the Board discussed several meetings back that has not been resolved. She asked the Board chair to look into the matter for status.
