PACE ACADEMY TRANSPORTATION RULES AND REGULATIONS

Each student who rides the van/bus is entitled to a safe and comfortable ride. Riding the van/bus is a privilege granted to the students under conditions set forth by PACE Academy, the state of Arizona, and the Department of Transportation. The van/bus is an extension of the school. Rules that apply within the school regarding behavior and consequences apply equally on the van/bus.

The following safety rules must be followed:

GENERAL

- ALL class room rules apply to students while on the van/bus. Please refer to Student/Parent Handbook.
- Riding the van/bus is a privilege. Do NOT abuse it. Remember the driver is in charge and these privileges may be revoked.
- If you are the only student we pick up at a stop please use transportation regularly or we may have to change your stop location.
- Be attentive to your personal hygiene. Body odors or unclean clothing may smell offensive and result in loss of van/bus privileges.
- Students getting off the van/bus at a stop other than their regular stop must have a written permission signed and dated by their parent/guardian and approved by office staff with 24 hour prior notice.
- For the safety of all concerned, vans are equipped with video and audio recording equipment.

WAITING AT THE VAN/BUS STOP

- Please be at the van/bus stop **10** minutes prior to pick-up time.
- Please allow the driver no less than 5 extra minutes after scheduled time for possible traffic delays.
- Do not damage property or violate school rules while waiting for the van/bus.
- There is to be NO SMOKING at the van/bus stop. All school rules apply at the pick-up locations

ON THE VAN/BUS

- Seatbelts **MUST** be worn **CORRECTLY** at ALL times.
- Please do NOT remove seatbelt until van comes to a complete stop at your destination.
- Remain in your seat, facing forward when the van/bus is in motion. All body parts are to remain in the van/bus at all times.
- Obey the directions of the transportation driver.
- Keep aisles clear of legs and other items at all times.
- Objects are NOT to be thrown in or outside of the van/bus.
- Hitting, bullying, loud or unnecessary noise or boisterous conduct will not be tolerated.
- Profanity or other inappropriate language or gestures are prohibited.
- "In School" rules regarding cigarettes/tobacco products/drugs apply. The van/bus is an extension of the school.
- Animals, glass or other dangerous objects are not allowed.
- Vandalizing or damaging the van/bus or property of others is never allowed.
- NO student shall deny any other student the right to sit in any seat.
- Please do not listen to music without ear buds or headphones or the device will be held for you until you arrive at school.
- Please do NOT over use perfume/cologne as others may have allergies and/or sensitivities.

EXITING THE VAN/BUS

- Wait for the van/bus to come to a **COMPLETE** stop before opening the door to enter and exit.
- Look continuously from left to right as you walk away from the van/bus. Be **AWARE** of your surroundings.
- Do NOT run to, from or while exiting the van/bus.

Please sign and return this agreement verifying you have read and understand the conditions set forth. Your signatures indicate that parent/guardian and student have read and understand all transportation rules. You may request a copy of these rules for your records.
