## **REPORTS:**

<u>Elouise:</u> Navajo School Clothing has been disbursed, the one that were not picked up will be returned. Accepting application for 2019-2020 will start the end of July. Update on Central office- A financial audit was conducted. Elrita Harvey, the Senior Accountant came and audited us. She went through all the budgets and we did well.

The way our IEC members represent their chapters is working for us. Central JOM can see that ours functions very well, if something is functioning, why mess with it is what we told them. That is why it would be good for IEC Members to attend the sub-contractor's meetings every year. I would like us to use all the funds this year, to the penny. Elouise handed modified budget documents to Elrita at Sub-contractor's meeting. Sub-contractor's meeting went well. This conference was held in the middle of the week, so most of the schools did not have their IEC members there except Gallup (which is a 45 minute drive to Sky City) Applications are due March 29<sup>th</sup> for SY2019-2021. The government shut-down is affecting the programs at JOM. The Navajo Nation is preparing for another 30 days. In the future, Elrita suggests that we can have IEC members at the financial reviews. She'd like to have more participation. She'll be back out in the spring. It is very important to go through the agenda and pay attention to the budget and your roles and responsibilities. Review your by-laws and CFR's.
