APPOINTMENT OF THE SUPERINTENDENT OF SCHOOLS

RESOLUTION APPOINTING SUPERINTENDENT

WHEREAS, Paulsboro Public School District Superintendent Dr. Laurie Bandlow retired effective June 30, 2019; and

WHEREAS, Dr. Walter Quint has served as the Interim Superintendent of the Paulsboro Public School District since on or about August 13, 2019; and

WHEREAS, the Board of Education of the Borough of Paulsboro has the need to appoint a permanent Superintendent; and

WHEREAS, the Board of Education of the Borough of Paulsboro has conducted a search to select a permanent Superintendent; and

WHEREAS, the Board of Education of the Borough of Paulsboro has selected Dr. Roy Dawson to serve as its permanent Superintendent; and

WHEREAS, the proposed Employment Contract between the Board of Education of the Borough of Paulsboro and Dr. Dawson has been submitted for approval to the Executive County Superintendent for Gloucester County; and

WHEREAS, the Employment Contract between the Board of Education of the Borough of Paulsboro and Dr. Dawson has been approved by the Executive County Superintendent;

NOW, THEREFORE, BE IT RESOLVED THAT the Board of Education of the Borough of Paulsboro hereby approves the appointment of Dr. Roy Dawson to be its Superintendent of Schools, for a term beginning on or about August 28, 2020 and ending June 30, 2024, subject to the laws of the State of New Jersey and subject to the terms and conditions of the Employment Contract which has been reviewed and approved by the Executive County and which is hereby approved by the Board of Education; and be it further

RESOLVED that the Board President and Board Secretary are hereby authorized and directed to execute the Employment Contract in the name of the Board of Education of the Borough of Paulsboro.
