## **Request for Proposal**

The Phenix City Board of Education is seeking proposals from qualified contractors for the following projects: repair, mill, and asphalt the track at Central High School, as well as asphalt the parking lots at Central High School and the Phenix City Intermediate School.

Contractors who have been approved to bid pursuant to prequalification procedures outlined by the Phenix City Board of Education will be eligible to bid on the projects. Performance and payment bonds, as well as evidence of insurance outlined in the bid documentation will be required before a contract can be awarded. A pre-bid meeting is scheduled for **Monday, January 8**, **2018, at 11:00 AM, Eastern Time**, at the Phenix City Board of Education, 1212 Ninth Avenue, Phenix City, AL 36867. Attending the pre-bid meeting is not required, although highly recommended.

Bid documents may be obtained or either requested from Nathan Walters, Maintenance and Operations, at 1212 Ninth Avenue, Phenix City, AL 36867. The deadline for receipt of sealed proposals is: **Monday, January 22, 2018, at 11:00 AM, Eastern Time**, at which time the proposals will be publicly opened and read aloud. The awarded vendor must complete the track project for Central High School by **June 1, 2018**, and the remaining paving work completed by **July 25, 2018**. Upon completion of the evaluation and vendor selection, an award may be made to the responsible offeror whose proposal will be most advantageous to the Phenix City Board of Education, price and other factors considered. Scope of Work

- A) Asphalt Repair
  - 1. This items consists of 3 areas, totaling 819sy per the attached diagram.
  - 2. The areas will need to be removed to a depth of 22 inches.
  - 3. Line to bottom of the 3 areas with Tensar TriAX Grogrid.
  - 4. Install 18 inches of Graded Aggregate Base Material.
  - 5. Install 4 inches of 424 1inch Asphalt Paving.
  - 6. All items will be installed per the Alabama Department of Transportation Standard Specifications for Highway Construction latest addition.
- B) Asphalt Resurfacing
  - 1. This item consists of 18,471 sy per the attached diagram.
  - 2. All tie in areas to existing asphalt paving only shall be edge milled to a depth of 1.5" to make a smooth transition.
  - 3. The existing surface shall be clean of all debris prior to any placement of Asphalt.
  - 4. Install Tack Coat Prior to ALL Asphalt Placement at a rate of .06 gallons per sy.
  - 5. Install a asphalt leveling coarse in any low areas to prevent any ponding of water prior to installing the wearing surface. The contractor with determine the areas of leveling.
  - 6. Install 1.5" of 424 1/2inch Asphalt Wearing Surface.
  - 7. All items will be installed per the Alabama Department of Transportation Standard Specifications for Highway Construction latest addition.

C) Parking Lot Striping

1. Install Paint Striping back to existing layout. This includes all Parking Spaces, arrows, Handicap spaces, Painted Curbs, stop bars, Stop lettering, Hashed Areas.





GF 2018 – 03 Central High School Track Repair, Milling, and Asphalt Resurfacing (Please see attached diagram)

Scope of Work

- A) Asphalt Repair
  - 1. Contractor will determine areas to be patch prior to asphalt placement.
  - 2. The areas will need to be removed to a depth of 10inches.
  - 3. Install 6 inches of Graded Aggregate Base Material.
  - 4. Install 4 inches of 424 1inch Asphalt Paving.
  - 5. All items will be installed per the Alabama Department of Transportation Standard Specifications for Highway Construction latest addition.
- B) Asphalt Resurfacing
  - 1. This item consists of 6,260 sy per the attached diagram, including all asphalt areas inside track
  - 2. All areas shall be Milled to a depth of 1"
  - 3. The existing surface shall be clean of all debris prior to any placement of Asphalt.
  - 4. Install Tack Coat Prior to ALL Asphalt Placement at a rate of .06 gallons per sy.
  - 5. Install a asphalt leveling coarse in any low areas to prevent any ponding of water prior to installing the wearing surface. The contractor with determine the areas of leveling.
  - 6. Install 1.5" of 424 1/2inch Asphalt Wearing Surface.
  - 7. All items will be installed per the Alabama Department of Transportation Standard Specifications for Highway Construction latest addition.



GF 2018 – 03 Phenix City Intermediate School Asphalt Resurfacing

- 1. This item consists of 1,551 sy per the attached diagram.
- 2. All tie in areas to existing asphalt paving only shall be edge milled to a depth of 1.5" to make a smooth transition.
- 3. The existing surface shall be clean of all debris prior to any placement of Asphalt.
- 4. Install Tack Coat Prior to ALL Asphalt Placement at a rate of .06 gallons per sy.
- 5. Install a asphalt leveling coarse in any low areas to prevent any ponding of water prior to installing the wearing surface. The contractor with determine the areas of leveling.
- 6. Install 1.5" of 424 1/2inch Asphalt Wearing Surface.
- 7. All items will be installed per the Alabama Department of Transportation Standard Specifications for Highway Construction latest addition.

B) Sealcoating

- 1. This item consists of 6700 sy per the attached diagrams.
- 2. Sealant Material: Contractor shall use GemSeal Poly Tar pavement sealer.
- 3. Contractor shall apply two coats of Poly Tar.

4. Contractor shall use a Motorized Squeegee Machine to Apply First Coat of Poly Tar, and Shall Spray the second coat per Manufactures specifications.

C) Parking Lot Striping

1. Install Paint Striping back to existing layout. This includes all Parking Spaces, arrows, Handicap spaces, Painted Curbs, stop bars, Stop lettering, Hashed Areas.
