1. **MEETING OPENED:**

Dr. Duff and the Board told the concerned citizens that at this time due to the high cost involved no action would be taken on the demolition of the old school buildings.

7. AYP REPORT:

Alma Somerville gave a presentation on the adequate yearly progress status for 2012-13 for the Pickens County schools. She told the Board that the data used to determine AYP was based on school year 2011-12 data and that every school in the Pickens County System made AYP for 2012-13 school year. Dr. Duff and Jamie Chapman both brought to the attention of the Board that many of the large systems who have more funding and new state of the art school did not make AYP but Pickens County, working with less, did make AYP. Both commended the entire Pickens County staff for going above and beyond what is expected for the students of Pickens County.
