The Pickens County Board of Education met on September 10, 2013 at 6:00 p.m. at the Central Office (377 LaDow Center Circle, Carrollton, AL 35447). Chairman, Nick Tolstick, LaSonja Richardson, Annie Jackson, Michael Hinton, and Debbie Holley were present. ### 1. **MEETING OPENED:**

Chairman, Nick Tolstick welcomed everyone to the September 10<sup>th</sup> Board Meeting and asked that a moment of silence

be observed.

### 2. **AGENDA APPROVED:**

On a motion by LaSonja Richardson, seconded by Debbie Holley the agenda was approved with the addition, *IV.E.Capital Improvement Plan*.

#### 3. **MINUTES APPROVED**:

On a motion by Debbie Holley, seconded by Annie Jackson the minutes of the August 28, 2013 meeting was unanimously approved.

#### 6. **FEASIBILITY STUDY:**

Dr. Steve Salmon and Mr. Steve Bennett presented their findings of the feasibility study conducted by RKR Planning Services LLC of Bremen, GA. Relying primarily on data from the U.S. Censuses of 2000 and 2010, the Center for Business and Economic Research at the University of Alabama, and the Alabama Department of Public Health, RKR compared data of the county as a whole to the state and the West Alabama region. RKR noted that during the past decade that Pickens County's overall population has declined by 5.74 percent. In 2000 Pickens County's population was 20,949 and there were 3,768 students enrolled in K-12, or 17.99 percent of the population. In 2010 the county's population was 19,746, and there were 2,055 students enrolled in K-12 or 14.97 percent of the population. The statistics showed that live births have been declining in Pickens County since 1990 and that trend is likely to continue. Enrollment in Pickens County schools has been in decline for several years and one reason given for the decline is that Pickens County's population has gotten older over the decades. The study looked at the enrollment of each school, determined what the capacity of each school could be based on its building space. Overall, the study says enrollment in 2012-2013 was 2,733, but all of the schools could have accommodated 3,887 students so the county as a whole is 1,154 under capacity or only utilizing 70.31 percent of its building capacity. RKR projected that if the decline in enrollment continues, the building utilization factor will continue to decline. By 2022-2023 school year, if the enrollment has dropped to 2,216 and the number of schools buildings was unchanged, only 57 percent of the building space would be used.
