_____ Pike Road School may refer cases in which false information has been intentionally provided to the Montgomery County District Attorney for further action as a result of providing false information.

_____ Persons who provide false information are subject to criminal prosecution for perjury which is punishable by fine and/or imprisonment (up to one year imprisonment in the county jail and up to a \$6000 fine). Ala. Code, §§13A-10-102, - 103 and -109 (1975).

_____ Persons providing false information also are civilly liable for fraud and misrepresentation. Parties found civilly liable may be required to pay all damages caused to Pike Road School as a result of providing false information. Ala. Code, §6-5-100, et seq. (1975).

_____ Persons who induce obtain, solicit or conspire with another person to provide false information are subject to criminal prosecution, fines and imprisonment as well as the person who directly committed perjury. Ala. Code, §§13A-4-1 and-3 (1975).

_____ Investigations that reveal that a student was enrolled based on false information will lead to the immediate withdrawal of the student from Pike Road School.

If you reside in shared housing YOU must provide:

- 1. Current driver's license or Government issued ID, and
- 2. One of the following: W2, 1099, or Pay stub, with the Second Party address name at the address of the home owner.
