## SPECIAL EDUCATION DEPARTMENT

As we all look forward to the warmer temperatures and the smells that are associated with Spring time, we can take a deep breath because we have almost made it through the winter months.



We have been very busy here in the Special Education Department in the past months as we prepare for the roll out of the Common Core State Standards. We also continue to provide support to our counties by providing Nonviolent Crisis Prevention training to those staff members at each school as specified in Policy 4373.

The picture shows all of our county **Special Education Directors and some Special Education Specialists** at our most recent RESA 4 directors meeting which was held at Braxton County Board of Education. Continue to stay warm and remember that Spring is right around the corner.

## ACAMS Training for County Asset Managers

**ACAMS**, which stands for Automated Critical Asset Management System, is a tool used to collect and organize information about critical infrastructure assets. ACAMS is a secure, Web-based information services portal used to support infrastructure protection efforts at the state and local level.

Provided by Department of Homeland Security for state and local first responders, emergency managers, and homeland security officials, ACAMS is an optional, no-cost software application that provides access to a comprehensive set of tools and resources to develop and implement critical infrastructure protection programs. At its core, ACAMS provides for the collection and effective use of critical asset data, protection information, and incident response and recovery plans pertaining to critical infrastructure assets. While ACAMS focuses on pre-incident prevention and protection, it can also be used to assist in post-incident response.

Participants took part in classroom lectures and practical hands-on learning exercises related to the ACAMS process. The training culminated with an assessment of an actual critical asset. During this assessment, all aspects of the ACAMS classroom instruction are incorporated, exercised and tested.

ACAMS provides the framework for the development of a comprehensive Critical Infrastructure Protection (CIP) Program. The Department of Homeland Security provides ACAMS at no cost to the state and local community to support infrastructure protection efforts.



## WVEIS Points to Ponder

- ◆ **FY2014 will be the first year that all teacher evaluations, for all schools, for all counties are required to be completed through WOW and the WOW version of discipline will be the only version of discipline available (no more 'green' screen discipline)**
  - ◇ All users at a school will need access to WOW, whether you are an administrator or a teacher
  - ◇ A quick way to get all teachers a WVEIS WOW user ID is to have them work through the tutorials at <http://wveis.k12.wv.us/teachers> and then have them click 'Obtain WVEIS ID'; IDs created through this method are passed through security measures to verify the employee's existence in the WVEIS system and the IDs are only given the evaluation menu item (but then our office or your county contact can adjust their menus for other needs)
  - ◇ This is also the site where teachers can work through the tutorials for the evaluation process
- ◆ Highly Qualified Teacher (HQT) submittals are upon us
  - ◇ Remember that these submittals are based in WOW this year (**NOT** WVEISweb)
  - ◇ All procedural questions and concerns should be passed through the Office of Professional Preparation
  - ◇ Be certain that your teachers are defined with the correct employee ID (STU.240) and that they are assigned to a valid course code in the master schedule (SCH.320) which they are endorsed to teach
  - ◇ **DO NOT USE the 4 digit endorsement code as a course code**
- ◆ A few of our counties are already working in FY2014, so be aware of what fiscal year you are working in and for what purpose if you have multiple years' worth of assignments.

## MEDICAID UPDATE

The Medicaid program is going well as we move towards the end of the fiscal year. There may be some upcoming changes to our billing process in the very near future, but those changes are currently in the decision making phase. The changes may also determine how we bill some of our current services provided to Medicaid eligible students.

We have still had quite a few new providers to enroll in our program, and I am sure we will continue to get more enrolled. I will soon be traveling to my next Medicaid Specialist meeting in March to learn about any

updates or changes to the Medicaid program. We are moving forward into our next session of the Random Moment Time Study System. This system is used to gather information related to the Medicaid program, where participants complete their "moments" which help to determine the amount of time spent doing Medicaid related activities. The thought behind this study is that it will help, not hinder, our Medicaid program.


**BOOK STUDY 1004.07**

**Teaching with Poverty in Mind: What Being Poor Does to Kids' Brains and What Schools Can Do About It - includes 2-set DVD Elementary/Secondary (Eric Jensen, 2009, ASCD) 25 per set** – After setting forth a detailed discussion of the damaging effects of poverty on the brains of disadvantaged children, the bleak picture brightens with offsetting research to support significant effects of a positive, enriching environment. Each chapter follows a veteran teacher in a high-poverty secondary school as he progresses from despair to commitment, learning to structure a productive classroom around what kids raised in poverty need. The book is structured with *Theory/Research* sections followed by *High Poverty Schools Making it Happen* sections, and research-based *Action Steps* sections designed as a practical guide to replicating these changes in your school.

**Teaching in Tandem: Effective Co-Teaching in the Inclusive Classroom (Gloria Lodato Wilson, Joan Blednick, 2011, ASCD) 25 per set** --- The question/answer format and the introductory vignettes of each chapter (which target content information) provide an organized reference valuable to teachers (every grade and subject), principals, administrators, and paraprofessionals. Basic definition of authentic co-teaching expands into how-to guides for planning, curriculum, instructional strategies, and other elements of a successful inclusive classroom. Case studies highlight common issues and approaches to solutions; roles of administrators and paraprofessionals are discussed in detail; parent and student concerns are explored and addressed.

## Department of Technology

The RESA 4 **Technology Department** continues to serve its six counties by providing a variety of technology services.

Cabling has begun on the new Gauley River Elementary School in Nicholas County. The department will be installing over 300 plus Cat 6 drops for both internet and phone services. In addition, our technicians will be installing the fiber optic cables between the wiring closets. The job began the early part of February.

The technology department also received an additional 12 BTOP routers and is currently configuring and installing those in their designated counties. Nicholas, Braxton, and Greenbrier counties will all receive new BTOP routers.

**The Child & Adult Care Food Program** theme is, "The Food Program is a **WIN-WIN-WIN** for parents, children, and providers." *Research proves that good nutrition in young children not only contributes to their physical growth, but to their intellectual and emotional development as well. Children who participate in the CACFP have the opportunity to acquire positive eating habits that will lead to a lifetime of good eating habits and good health.*



**BENEFITS TO THE CHILD**

The Child & Adult Care Food Program (CACFP) offers lifetime benefits. Proper nutrition during the early years of childhood ensures appropriate development and reduces physical and educational problems later in life. The preschool years are when eating patterns and habits are being established that may determine the quality of one's diet throughout life. Children who are in child care with providers who participate on the CACFP are given the opportunity of nutrition education by providers who understand their role in shaping attitudes toward the acceptance of nutritious foods.

**BENEFITS FOR THE FAMILY CHILD CARE PROVIDER**


Providers receive valuable nutrition education that helps them know the proper foods to feed children in amounts appropriate for these young age groups. They receive help through nutrition education and personal visits from CACFP staff in understanding how to encourage positive eating habits that will benefit a child throughout life. They help children make healthy food choices for their meals and snacks that will last a lifetime.

**BENEFITS FOR THE PARENTS**

Parents are assured that their children will be served high quality meals. The benefit is children are less likely to experience fatigue and illness, and less time a parent must be absent from work. The child is also more likely to be healthy, happy and develop at a normal physical, emotional and intellectual pace.

**BENEFITS FOR THE COMMUNITY**

Because of the CACFP, federal tax monies are returned to the provider's state and invested in the health of the community's children. The added revenue is a means of helping to keep child care costs down for employees working in the community. Since only regulated providers are eligible to participate in the program, this provides an incentive for unlicensed providers to comply with local child care ordinances.

Common Ground also helps support military families through the Interstate Compact, which honors out-of-state academic credits from children of military members who transfer into the West Virginia school system.


