Position: Full-Time Head Start Pre-K Teachers in Berkeley County

Number of Positions: Two (2)

Employment Term: 200 days per school year

Salary: Based upon the EPIC professional salary schedule

Qualifications: Candidate must hold or be eligible for a WV Department of Education Pre-Kindergarten professional teacher certification or permit. A long-term sub may be considered for this position if there are no fully certified applicants and the selected candidate meets all requirements for a WV long-term substitute teaching permit.

Job Description/Responsibilities: Establish a safe and healthy classroom environment; prepare weekly, intentional and detailed lesson plans, provide warm high-quality adult/child interaction; screen children; track children's progress on TS Gold and WV ELS; maintain online portfolios; conduct home visits and parent conferences; involve parents directly in classroom activities; participate in professional development; etc. Teachers may need to provide instruction and student support services remotely if students are attending school remotely or in the event of temporary or extended classroom closure due to COVID-19.
