While all these types of assessments should influence instruction and lead to student achievement, research supports the most influential type of assessments are the formative ones. Formative Assessment is a process that includes learning target, success criteria, descriptive feedback, and ownership of self-assessing. It is used to influence the teaching as well as the learning practice. This Administrative Academy will look deeper into the formative assessment process and how it can be successfully implemented into classrooms.
