- 2) Vote on budget and set tax rate Mr. Vaughn read the 2018-2019 budget resolution and the tax rate: Imposing the Tax- Be it resolved that the following ad valorem property taxes are hereby imposed upon the assessed value of all taxable property within the district for tax year 2018-2019: At the rate of \$5.436 per \$1000 of assessed value for permanent rate tax Categorizing the tax: Be it resolved that the taxes imposed are hereby categorized for purpose of Article XI section 11b as: Subject to the Education Limitation-Permanent Rate Tax \$5.436/per \$1000. This brought up the subject of the district trying for a bond with safety in mind. There are many options to consider including suggestions from the safety committee. This subject will need to be discussed further.

- 9) Move 6th grade to Jr. High This is an idea that need much consideration and would take at least 18 months before any move would be made. All possibilities and ideas must be looked at before this can take place. This needs to be placed on future agendas and needs collaboration from the community.
- 10) Discipline/Behavior in buildings The district has been made aware of the discipline issues in both schools and that are growing. The common thread seems to be lack of enforcement. The Board will review the handbooks and enforce them in the 18-19 school year. This subject needs to be moved to future agendas.

- 11) Promise Oregon Scholarship update The Board has been awarded the Promise Oregon Scholarship and will receive 18 hours of Board training along with a student scholarship.
- 12) Superintendent Evaluation debrief Ms. Hollander and Mrs. Richardson are having Superintendent Evaluation meetings with a third Board member rotating in. Mr. Harding is concerned as he thought the committee was working on goals and not the evaluation. Ms. Hollander explained that the committee is having these meetings as check-ins with Mr. Carter. Mr. Harding would like to be the next person to rotate into the committee.
- 13) Bring Hudson Park teachers back one day early on August 28, 2018 Mr. Carter would like permission to bring teachers back one day early next year to work on getting their classrooms together after the seismic upgrade. The Board gave Mr. Carter the nod yes to this idea.
