Administration

Ms. Foust, Assistant Superintendent of Curriculum and Instruction presented to the Board a new Policy - 4003 Translating Policies for Students and Parents as a first reading. The policy will be presented at the September Board Meeting for approval.

B. Coltrane made a motion seconded by G. Mason to approve policies 5030 Exhibit 1 Community Use of Facilities, 5015 Volunteers and 7140 Criminal History as presented and discussed previously during the Board Work Session. Motion carried: 7-0.

Instruction

Ms. Kim Johnson, Director of Secondary Education, presented the 2012 Graduation Statistical Information and Scholarship Report. Ms. Johnson stated the National Clearing House will be used to track students. There were 1,137 diplomas issued and 14 certificates with 32.81% going to public and/or private four-year colleges, 49.87% going to community colleges, private junior colleges and trade schools, 5.36% entering the military, 10.99% entering the workforce. In all, 1,001 students accounting for 88.04% of all graduating seniors are planning to further their education. The total monies awarded to Randolph County graduates toward furthering their education was \$22,544,704.00.

Personnel Report/Principal Recommendation

Ms. Brady recommended the personnel report as presented along with a recommendation of Ms. Debbie Sheron to serve as the Interim Principal for Level Cross through June 30, 2013. J.
