A returned check fee will be in effect this school year. Parents and students paying for school meals will be charged a \$30.00 returned service fee in addition to fees their bank may charge. The Rhea County Board of Education has entered into an agreement with Paylance, Inc. for the collection of all returned checks issued to all Rhea County locations.

The Board requires that you make sure the following information is on all checks written:

- \* Full Name
- \* Street Address
- \* Home Phone Number

If your check is returned by your bank, it will be automatically forwarded by the Rhea County Board of Education's bank directly to Paylance after the first presentation.

**Check Payment Terms:** In consideration of merchant accepting customer's payment by check, and other good and valuable consideration, Customer agrees that if any check is returned unpaid for any reason, customer expressly authorizes merchant or its processing agent or assignee to electronically collect or create a demand draft to collect the face amount of the check, and a **\$30** return check service fee as well as any applicable bank fees and sales tax. Customer's payment by check is customer's express acceptance of the terms and shall serve as customer's authorization for the electronic collection and /or demand draft on customer's account.
