According to Section 59-40-50 (5) of the South Carolina Charter School Act, which pertains to teacher certification and flexibility, charter schools (non-conversion schools) must, at a minimum, have 75% of their core classes taught by appropriately certified and highly qualified teachers. In addition, the law provides flexibility for charter schools to allow up to 25% of its core courses to be taught by teachers who are noncertified or who are certified, but are not highly qualified in the subject area(s) to which they teach. As per the South Carolina Department of Education, Office of Federal and State Accountability, these teachers need to **demonstrate content knowledge** for each core class to which they are the teacher of record. If content knowledge can be demonstrated, the teacher is considered, "allowable to teach that particular course."

If your child is taught by someone who is not highly qualified for more than 20 consecutive days, even though he or she might possess a baccalaureate or graduate degree in the subject he or she was hired to teach, the Elementary Secondary Education Act (ESEA), requires that your child's school notify you in writing of this.
