Admission of Nonresident Students

Determination of whether a student is a resident or nonresident will be initially accomplished by interview with the guidance counselor and/or administrator at the school.

If there is a question as to the determination, the matter will be researched by the school principal, who in turn will consult with the superintendent.

If residency is confirmed because the student is in a parental relationship (JECAC-R) with an adult other than the parent(s) or legal guardian, the principal will require that the appropriate documentation (District form or court document) be completed and filed in order for the enrollment to receive final approval.

If the parent is requesting tuition admission, the following process will be used.

1. All requests related to tuition admissions will be referred to the superintendent.
2. The superintendent will request and receive a written parent statement of the reason(s) for requesting a tuition admission. Educational records may be requested.
 - a. The superintendent and the appropriate principal will review and consult regarding the request.
 - b. The parties will be notified in writing of the administrative decision.
3. Approved requests will result in a tuition agreement between the parties. The agreement will be filed with the Business Manager for billing and payment control. Tuition will be based on per student costs. Final billings will include a notice that continued admission requires a revised rate and a written confirmation of continuation by the parent.

Other nonresident enrollment requests will be referred to the superintendent.

Each principal is responsible for determining that no student is enrolled in school in violation of Board policy and these regulations.

(3) It is agreed that this Affidavit is the inducement and the consideration for the District officials in allowing the child named herein to enroll in the District schools.

(4) It is, specifically, acknowledged, agreed and understood by all parties executing this Affidavit that should any of the statements made herein be found to be false or misleading in any way, then, at the sole discretion of the District, the following sanctions could occur:

- (a) Enrollment of this child in this District may be terminated immediately.
- (b) All of the tuition charges expended on behalf of this child, or thereafter expended, shall be assessed jointly and/or severally against the parties executing this Affidavit. Additionally, should the District deem it necessary to employ legal counsel to collect this tuition from the responsible parties, it shall be entitled to recover fees paid to legal counsel in connection with this matter with or without formal legal proceedings, together with its costs and disbursement, if any, incurred in pursuing the matter.
