PUBLIC HEARING OF THE 2015/2016 BUDGET

A. RESOLUTION APPROVING THE SUBMISSION OF THE 2015/2016 BUDGET TO THE STATE OF NEW JERSEY, DEPARTMENT OF EDUCATION FOR THE SPOTSWOOD BOARD OF EDUCATION

WHEREAS, the Spotswood Board of Education must prepare and submit a budget to the State of New Jersey, Department of Education on a yearly basis; and

WHEREAS, the Spotswood Board of Education has prepared a budget for the 2015/2016 school year; and

WHEREAS, the final budget must be approved by the Spotswood Board of Education prior to submission to the Department of Education;

WHEREAS, the final budget is as follows:

WHEREAS, the budget includes no Commissioners Adjustment to the base tax levy.

WHEREAS, school district policy, 9250 B1, Expenses and Reimbursement and N.J.A.C. 6A:23:b-1.2(b) provides that the board of education shall establish in the annual school budget a maximum expenditure amount that may be allotted for such travel and expense reimbursement for 2015/2016 school year.

NOW THEREFORE, BE IT RESOLVED that the Spotswood Board of Education hereby establishes the school district travel maximum and reimbursement amount for the 2015/2016 school year at the sum of \$59,050.00.

BE IT FURTHER RESOLVED that the School Business Administrator shall track and record these costs to insure that the maximum amount is not exceeded.

The maximum travel expenditure for the 2014/2015 School Year was \$59,050.00. As of February 28, 2015, \$16,732.55 has been expended to date.

NOW THEREFORE, BE IT RESOLVED that the Spotswood Board of Education, approves the submission of the final budget for the 2015/2016 school year.

FURTHER, WHEREAS, N.J.A.C 23A-5.2 requires the Spotswood Board of Education to establish a maximum dollar amount in the 2015/2016 budget for the following professional services: Architect - \$75,000.00, Auditor - \$63,000.00, Attorney - \$30,000.00, School Physician - \$7,000.00.

NOW THEREFORE, BE IT RESOLVED that the Spotswood Board of Education approves the submission of the final budget for the 2015/2016 school year.
