7. Mrs. Seals recommended approval of the FY 2008 Cost of Living Raise-effective at the beginning of the employee's contract. Mr. Brasher gave the motion and Mr. Thompson gave the second. All members voted in favor.

8. Board members offered the following comments:

A. Mr. Green questioned the interview process and said that principals need to always be professional and operate within the law.

B. Mr. Brasher said that someone had asked him why students that participate in extra curricular activities had to have physicals but not the students that participate in the band. He said it could be strenuous for students that may not normally get exercise. Mrs. Seals said that she would check out our board policy regarding student physicals.

C. Mr. DeGaris commented on the fact that some applicants have had to come to the board meetings to find out whether or not they are hired. He said that they have the impression that the decision is pending on board approval. He feels that there should be better communication between the principals and their applicants.

9. Mrs. Seals offered the follow comments:

A. Mrs. Seals thanked the board on behalf of the employees for the approval of the cost of living raise that will become effective at the beginning of their contracts. She said that they did not have to do it but they were gracious to approve the raise. She said that it was a good will gesture and she thanked them again.

10. President Scott Suttle recommended approval to adjourn. Mr. DeGaris moved to approve the recommendation.
