**STUDENT FIRST RESPONDER TRAINING  
PROGRAM AGREEMENT**

**THIS AGREEMENT** made and entered into this \_\_\_\_ day of \_\_\_\_\_, 2015 (the "Commencement Date"), by and between the St. Clair County Board of Education (hereinafter called the "Board") and the City of Pell City (hereinafter called the "City").

**WITNESSETH:**

**WHEREAS**, the City and the Board desire to establish a program to educate and train qualified students who attend the Board's school system in the basic skills required to perform services as a firefighter and first responder (the "Program"); and

**WHEREAS**, the Board and the City desire to formalize the responsibilities of the parties in connection with providing the Program to student applicants.

**NOW THEREFORE**, in consideration of the mutual covenants and recitals herein expressed, the parties hereto agree as follows:

- 1.) The City shall provide all facilities required to operate the Program, such as classrooms and drill fields.
- 2.) The City shall determine the content of the Program and provide necessary and appropriate teachers for the various subjects taught in the Program.
- 3.) The City may place limits on the number of student applicants accepted in the Program consistent with the number of teachers, equipment, and supplies available to it.
- 4.) The City shall provide all personnel protective equipment (i.e., turn-out gear, etc.), self-containing breathing apparatus (SCBA), testing supplies, and handouts.
- 5.) The Board shall provide the student applicants for the Program, textbooks to be used by such students, and transportation as is necessary and appropriate for students to attend the Program classes and field trips.
- 6.) The Board shall pay the City the sum of Ten Thousand and No/100 dollars (\$10,000.00) per year to reimburse the City for a portion of its costs in operating and maintaining the program.
- 7.) The parties shall divide equally any grant funds received by either party as a result of a grant application related to the Program.
- 8.) Neither the City nor the Board shall be responsible for providing students enrolled in the Program with physical training clothing, such as shorts, sweatpants, t-shirts, safety glass, or heavy duty gloves, or basic school supplies. Such items shall be provided by students.

This agreement shall be for a term commencing on the Commencement Date and terminating on June 1, 2016, and shall be renewed automatically for one year terms unless and until any party provides written notice to the other party at least sixty (60) days prior to the end of any term of its intention not to so renew.

10.) The City and the Board shall cooperate in all matters required to implement and accomplish the terms and intent of this agreement.

11.) This agreement may not be modified unless such modification is in writing and signed by all the parties to this agreement, and this agreement supersedes all prior agreements whether written or oral concerning the Program.



**AGREEMENT**

This Agreement (the "Agreement") entered into by and between the St. Clair County Board of Education (the "Board") and the City of Springville, Alabama (the "City") on this the \_\_\_\_ day of \_\_\_\_\_, 2015.

**WHEREAS**, the City desires to construct certain recreational facilities for the use and benefit of the citizens of the City and the children who attend the Board's schools located within the City; and

**WHEREAS**, the recreational facilities the City desires to construct include tennis courts and other necessary and ancillary improvements related thereto (the "Tennis Courts"); and

**WHEREAS**, the City has let for bid and entered into a contract with a company which will construct the Tennis Courts for a fixed sum; and

**WHEREAS**, the Board desires to assist in the construction of the Tennis Courts consistent with the terms and conditions set forth herein.

Now, therefore, for the mutual benefits and considerations set forth herein, sufficiency of which is hereby acknowledged, the City and the Board hereby agree as follows:

1. That all recitals set forth above are expressly adopted and incorporated as if specifically set forth herein.
2. That the Board shall contribute the sum of Twenty-Five Thousand and No/100 Dollars (\$25,000.00) toward the costs necessary to construct the Tennis Courts. The Board's contributions shall be paid in two installments of Twelve Thousand Five Hundred and No/100 Dollars (\$12,500.00) payable on October 15, 2015, and October 15, 2016, respectively.
3. That the City shall have the exclusive responsibility for the operation, repair, and maintenance of the Tennis Courts, and shall maintain comprehensive liability insurance covering the Tennis Courts and the activities conducted thereupon.
4. That the City shall ensure the Board is not responsible for any claims, demands for damages, causes of actions, or otherwise which may accrue as a result of any accident or injury to person or property arising out of the use of the Tennis Courts, other than may arise out of the negligent or willful acts or omissions by the Board, and its students, faculty, and staff in connection with the use of the Tennis Courts at a Board-sanctioned event (practice or match). Provided, however, nothing herein shall be construed in any way to abrogate, mitigate, or alter any statutory immunities or limitations of liability afforded by law to either the Board or the City.

The City and the Board shall pre-determine a schedule for said practices and matches, and the Board shall have priority in scheduling said practices and matches at the Tennis Courts (or those courts necessary).
