### **6.** The following audience members addressed the board:

### **RESOLUTION NO. 2015-3**

### A RESOLUTION AUTHORIZING THE PURCHASE OF CERTAIN REAL PROPERTY LOCATED IN SPRINGVILLE, ALABAMA

WHEREAS, the St. Clair County Board of Education ("the Board") has identified certain real property adjacent to land currently owned by the Board in Springville, Alabama, that could be used for the future expansion of the Board's school facilities in Springville; and,

WHEREAS, the Board has entered into a contract with the current owner of said real property, Mr. Gene Keith, for the purchase of approximately 28 acres of said property ("the Property") at the purchase price of \$32,000.00 per acre ("the Contract"); and,

WHEREAS, Mr. Keith has previously agreed to extend the closing date of the Contract to on or before December 1, 2015, to allow the Board additional time to complete the survey and inspections of the Property; and,

WHEREAS, the Board has completed the survey of the Property and is prepared to move forward with the purchase of the Property pursuant to the terms and conditions of the Contract, as extended and amended; and,

WHEREAS, the Board has determined that it is wise, prudent, and in the best interests of the St. Clair County School System to purchase the Property for the purposes of securing real property for the potential future expansion of the Board's school facilities in Springville.

NOW, THEREFORE, BE IT RESOLVED by the St. Clair County Board of Education, as follows:

**Section 1.** That the Chairman of the Board and the Superintendent be, and they hereby are, authorized and directed to execute the Extension and Amendment of General Sales Contract, in substantially the form and substance as attached hereto as Exhibit A and expressly incorporated herein by reference.

**Section 2.** That the survey of the Property to be purchased pursuant to the Contract, as extended and amended, which survey is attached hereto as Exhibit B and expressly incorporated herein by reference, is hereby adopted and approved by the Board.

Section 3. That the Chairman of the Board and the Superintendent be, and they hereby are, authorized and directed to take all such actions as shall be necessary to complete the purchase of the approximately 28.16 acres of property as demonstrated by the attached survey pursuant to the terms set forth in the Contact, as extended and amended, including, but not limited to, delivering payment of the purchase price, delivering payment of all closing costs, including the costs associated with the purchase of owner's title insurance in the amount of the purchase price, executing all documents necessary to consummate the sale and purchase of said property, and performing all other such acts necessary to consummate the sale and purchase of said property.
