The purpose of this project is to minimize the exposure and spread of COVID-19 through Sumter County Schools and the community. The project will consist of student entrance and an employee entrance deployed at nine (9) locations in the Sumter County School District.

Bid specification for the elevated temperature screening system should include:

- Signage
  - Notices
    - NOTICE: This is a body temperature measurement screening system and cannot diagnosis COVID-19, or any other disease.
    - NOTICE: If you have an elevated body temperature that is detected, you will be asked to have your temperature taken with a thermometer
- Withstand low, medium and high entryway traffic flows.
- Includes a Non-contact Infrared Thermometer (NICT)
- Must provide temperature accuracy of the screening in Fahrenheit.
- Face/body detection capability
- Capable of at least 50 scans per minute
- Capable of sending alerts/notifications to authorized personnel of identified elevated body temperature
- Does not require calibration and maintenance
- Warranty included
- Environment must not affect temperature screenings
- Must follow CDC, ADA, and HIPPA guidelines
