1 The Board authorizes the establishment and operation of Extended School Day/Year Programs in any  
2 of its schools to be conducted before and after the regular school day and during summer months and  
3 other times when school is not in session. Emphasis shall be placed upon extended education services  
4 for children even though fees are collected for school-age childcare. No Basic Education Program  
5 funds nor required BEP matching local funds may be used to support childcare provisions of the  
6 program.<sup>1</sup>

7 The Board shall determine fees to be charged for attending the program, taking into consideration such  
8 factors as family income, number of children to participate in the program, and amount of service  
9 provided.

## 10 **OBJECTIVES**

### 11 *Program Objectives*

- 12 1. To provide an enriching and flexible curriculum.
- 13 2. To provide for the safety and health of children.
- 14 3. To effectively use school facilities.

### 15 *Educational Objectives*

- 16 1. More guidance and increased learning time.
- 17 2. Quality homework time.
- 18 3. Quantitative data information.

## 19 **ELIGIBILITY**

20 The only requirement for eligibility is that the student must be enrolled in the school system.

## 21 **OPERATION**

22 The extended school day program shall operate on the regularly scheduled school days as follows:

- 23 Before school - 6:00 a.m. – beginning of school day
- 24 After school – End of school day - 6:00 p.m.
- 25 Any full day session - 6:00 a.m. - 6:00 p.m.

26 Children may enroll in one or both of the sessions, depending on family needs. The program shall  
27 operate daily on a year-round basis, including snow days, teacher in-service days and during the  
28 summer. All centers will be closed for the following holidays:

- 1 • 4th of July
- 2 • Labor Day
- 3 • Thanksgiving Day and the day after
- 4 • Christmas Eve Day
- 5 • Christmas Day
- 6 • New Year's Eve
- 7 • New Year's Day
- 8 • Good Friday and Monday following Easter (unless school is in session)

## 9 **USE OF FACILITIES**

10 The principal shall be responsible for assigning locations for use and alternate locations when  
11 designated areas are needed for regular school programs.

12 Instructional equipment shall be made available for the program with approval by the principal.

## 13 **PERSONNEL**

14 The Board shall establish a position of program director who shall be directly responsible to the  
15 director of schools. The Board shall determine responsibilities of the program director, one of which  
16 shall be to provide leadership in developing and maintaining the extended school day program.

17 Additional personnel may be employed as the Board deems necessary.
