1 Student progress reports shall be provided at least once every three week grading period during the  
2 school year. The reporting procedure shall be in writing and shall be uniform for all reporting periods  
3 during each school year.<sup>1</sup> Each report shall be signed by the parents and returned promptly to the school.  
4

5 Student progress reports shall indicate the students' conduct, attendance and academic progress and other  
6 information necessary to communicate effectively with the parents.  
7

8 In addition to the regular progress reports, principals and teachers are encouraged to confer with parents  
9 on the educational progress of their children. Teachers shall consult with parents of students who are  
10 working at an unsatisfactory level or whose performance shows a marked or sudden deterioration. Par-  
11 ents shall be notified by the teacher as early in the school year as possible if the retention of a student  
12 is being considered.

## 14 **DRIVER'S LICENSE REVOCATION**

15  
16 Any student fifteen (15) years of age or older who becomes academically deficient shall be reported to  
17 the Department of Safety for driver's license revocation.  
18

19 A student shall be deemed academically deficient if he/she has not received passing grades in at least  
20 one half of their subjects.  
21

22 A copy of the notice sent to the Department of Safety by the attendance teacher or the director of schools  
23 shall also be mailed to the student's parent or guardian.<sup>2</sup>

## 25 **PARENT CONFERENCES**

26  
27 At least two (2) times during the school year, conferences shall be scheduled in which parents and  
28 teachers may discuss any pertinent problems or other matters of concern regarding the development  
29 and education of each student. These scheduled conferences shall not use any portion of the 180 days  
30 of classroom instruction.<sup>3</sup> The director of schools shall be responsible for scheduling and coordinating  
31 systemwide conferences.  
32

33 Conferences shall be physically accessible to all students, parents and/or guardians.<sup>4</sup>
