1 In order to protect the rights of students, to safeguard the learning environment, and to contribute to a “Drug
2 Free” community, the Board’s plan for dealing with alcohol and drugs¹ shall include the following:
3

- 4 1. Appropriate ways for handling alcohol/drug-related medical emergencies;
- 5 2. Guidelines for reporting alcohol/drug incidents and illegal activities;
- 6 3. Guidelines for referral of students who may have an alcohol/drug problem and/or are considered
7 "high risk" to agencies and other sources of appropriate help;
- 8 4. Effective working relationships with appropriate community agencies, such as alcohol/drug service
9 providers, law enforcement agencies and judicial officials.

11 Through the use of state guidelines the director of schools shall be responsible for:

- 12 1. Developing and implementing an appropriate curriculum on alcohol and drug education for students;
- 13 2. Providing adequate information and training for all staff personnel as appropriate to their respon-
14 sibilities;
- 15 3. Implementing the relevant portions of the Drug-Free Youth Act² ;
- 16 4. Developing administrative rules and guidelines for the school system to effectively respond to
17 alcohol and drug situations that may occur at school or school-sponsored events; and
- 18 5. Providing notification to parents and students that compliance with this policy is mandatory.

21 Students will not consume, possess, use, sell, distribute or be under the influence of illegal drugs or alcoholic
22 beverages in school buildings or on school grounds at any time, in school vehicles or buses, or at any school-
23 sponsored activity, function or event whether on or off school grounds. This includes but is not limited
24 to abuse of inhalants and prescription drugs.³

26 Disciplinary sanctions will be imposed on students who violate standards of conduct required by this policy.
27 Such sanctions will be consistent with local, state and federal laws, up to and including suspension/expulsion
28 as well as referral for prosecution.⁴ Completion of an appropriate rehabilitation program may also be
29 recommended.

31 Information about drug and alcohol counseling and rehabilitation programs will be made available through
32 the school office. The STAND Program will be used to implement the drug-free school policies/procedures
33 of the Board.
