- 1 The following levels of misbehavior and disciplinary procedures and options are designed to protect all
- 2 members of the educational community in the exercise of their rights and duties.¹

3 MISBEHAVIORS: Level I

- 4 Minor misbehavior on the part of the student which impedes orderly classroom procedures or interferes
- 5 with the orderly operation of the school, but which can usually be handled by an individual staff
- 6 member.

- 7 Examples (not an exclusive listing):
 - Classroom disturbances
 - Classroom tardiness
 - Cheating and lying
 - Abusive language
 - Non-defiant failure to do assignments or carry out directions
 - Wearing while on the grounds of a public school during the regular school day, clothing that exposes underwear or body parts in an indecent manner that disrupts the learning environment²
 - Harassment (Sexual, Racial, Ethnic, Religious)
- 17 *Disciplinary Procedures*:
 - Immediate intervention by the staff member.
 - Determine what offense was committed and its severity.
 - Determine offender and that he/she understands the nature of the offense.
 - Employ appropriate disciplinary options.
- Record of the offense and disciplinary action maintained by staff member.
- 23 Disciplinary Options:
- Verbal reprimand
 - Special Assignment
 - Restricting activities
- Assigning work details
- Counseling
- Withdrawal of privileges
 - Issuance of demerits which might affect citizenship or deportment grades

Discipline Procedures 6.313

1 MISBEHAVIORS: Level III

- 2 Acts directly against persons or property but whose consequences do not seriously endanger the health
- 3 or safety of others in the school.

- 4 Examples (not an exclusive listing):
 - Continuation of unmodified Level I and II behaviors
 - Fighting (simple)
 - Vandalism (minor)
 - Use, possession, sale, and/or distribution of tobacco, drugs, and/or alcohol
 - Stealing
- Threats to others
 - Harassment (Sexual, Racial, Ethnic, Religious)
- 12 Disciplinary Procedures:
 - Student is referred to principal for appropriate disciplinary action.
 - Principal meets with student and teacher.
 - Principal hears accusation by accusing party and permits offender the opportunity of explaining conduct.
 - Principal takes appropriate disciplinary action.
 - Principal may refer incident to director of schools and make recommendations for consequences.
 - If student's program is to be changed, adequate notice shall be given to the student and his/her parents of the charges against him, his/her right to appear at a hearing and to be represented by a person of his/her choosing.
 - Any change in school assignment is appealable to the Board.
 - Record of offense and disciplinary action maintained by principal or director of schools.
- 25 Disciplinary Options:
- In-school suspension
- Detention
 - Corporal punishment
 - Restitution from loss, damage or stolen property
- Out-of-school suspension not to exceed ten (10) days
 - Social adjustment classes
- Transfer
- Expulsion
- 34 MISBEHAVIORS: Level IV
- 35 Acts which result in violence to another's person or property or which pose a threat to the safety of
- others in the school. These acts are so serious that they usually require administrative actions which

result in the immediate removal of the student from the school, the intervention of law enforcement 1 2 authorities and/or action by the Board. 3 Examples (not an exclusive listing): Unmodified Level I. II and III behaviors 4 Death threat (hit list) 5 Extortion 6 7 Bomb threat Possession/use/transfer of dangerous weapons * 8 Assault/Battery * 9 Vandalism 10 Theft/possession/sale of stolen property 11 12 Arson/Possession of unauthorized substances * Use/transfer of unauthorized substances 13 Harassment (Sexual, Racial, Ethnic, Religious) 14 Disciplinary Procedures: 15 16 Principal confers with appropriate staff members and with the student. Principal hears accusations and permits offender opportunity to explain conduct. 17 Parents are notified. 18 Law enforcement officials are contacted. 19 Incident is reported and recommendations made to the director of schools. 20 Complete and accurate reports are submitted to the director of schools. 21 Student is given hearing before disciplinary hearing authority. 22 Disciplinary Options 23 **Expulsion** 24 Alternative schools 25 Other hearing authority or Board action which results in appropriate placement 26 27 * Expulsion/Remand for a period of not less than one (1) calendar year subject to modification by the director of schools on a case-by-case basis. 28 ADDITIONAL GUIDELINES: 29 A student shall not be suspended solely because charges are pending against him/her in 30 juvenile or other court. 31

- A principal shall not impose successive short term suspensions that cumulatively exceed ten (10) days for the same offense.³

- A teacher or other school official shall not reduce or authorize the reduction of a student's grade because of discipline problems except in deportment or citizenship.
- A student shall not be denied the passing of a course or grade promotion solely on the basis of absences except as provided by board policy.

Discipline Procedures 6.313

- A student shall not be denied the passing of a course or grade promotion solely on the basis of failure to:
 - o pay any activity fee;
 - o pay a library or other school fine; or
 - o make restitution for lost or damaged school property.
