

# Hardeman County Board of Education

1 The Board shall operate an alternative school program for students in grades 7-12 who have been sus-  
2 pended or expelled from regular school programs.<sup>1</sup> Attendance in alternative school programs shall be  
3 mandatory and students attending an alternative school located other than at their home school shall  
4 provide their own transportation.

5  
6 Teachers in alternative schools shall be certified by the state and shall be selected on the basis of interest  
7 and ability to work in alternative situations.

8  
9 Student-teacher ratios shall be small enough to allow for adequate instruction but shall be determined  
10 by the age, behavior and academic achievement of students in the program.

11  
12 Sufficient textbooks, equipment and supplies shall be provided by the home school.

13  
14 Alternative school programs shall be operated in accordance with the rules of the State Board of Educa-  
15 tion<sup>2</sup> and instruction shall proceed as nearly as practicable in accordance with the instructional programs  
16 at the student's home school. All course work completed and credits earned in the alternative school  
17 shall be transferred to and recorded in the student's home school. Credit earned and progress made shall  
18 be granted as if the work were performed in the home school. No student may graduate based solely  
19 on attendance in alternative schools.<sup>1</sup>

21 Except students who are eligible for special education, such change in a student's program shall be  
22 determined by the disciplinary hearing authority in accordance with the suspension policy of the Board  
23 and based upon recommendations from a team composed of the principal, the school counselor and the  
24 student, with or without the parents being present.

25  
26 The student shall be subject to all rules of the school and violations of such rules may result in the  
27 student's removal from the school for the duration of the original intended suspension or expulsion.  
28 Violation of school rules shall not constitute grounds for extension of time spent in the alternative school.  
29 The final decision on such removal shall be made by the chief administrator of the alternative school.

30  
31 Students found to be eligible for special education in related circumstances shall be placed and served  
32 in accordance with the law and rules relating to special education.
