1 Any foreign student is eligible for acceptance into the foreign exchange student program, provided  
2 s/he is participating through any agency endorsed by the Council on Standards for International Edu-  
3 cational Travel and is sponsored by an individual or organization and has a J-1 visa.<sup>1</sup> Before approval  
4 by the Board, the exchange program representative must make written application on behalf of the  
5 student in the local school serving the host family. Students will only be accepted at the beginning  
6 of the local school year and must be from different nationalities. It is recommended that students  
7 should stay with different host families each year. The school may accept the student after determin-  
8 ing the following:

- 10 1. The student will participate in the general curriculum;
- 11
- 12 2. Appropriate curriculum offerings can be provided for the student; and

- 14 3. An overcrowded situation will not be further aggravated.

16 Prior to enrolling a foreign student, the principal or designee shall require, in addition to a valid stu-  
17 dent visa, the following documentation:

- 19 1. Citizenship;
- 20
- 21 2. Birthdate;
- 22
- 23 3. Health/immigration records;
- 24
- 25 4. Custody (including phone number, name and address of person responsible for the stu-  
26 dent); and

- 28 5. School records, including a transcript of academics (in English).

30 Admission requirements and all other considerations and expectations shall be the same for foreign  
31 students as for United States students. Students will be accepted only in grades 9-12. No more than  
32 two (2) foreign students shall be placed in one school.

34 Students must have had acceptable academic achievement in their native countries and must have  
35 been screened for maturity and ability to get the maximum benefit from an exchange program. Ex-  
36 change students must have an adequate command of the English language and be able to function  
37 without special assistance in regular classes. The principal shall be responsible for assignment to the  
38 appropriate grade level.

40 Each school shall name a faculty member as a student representative to serve as a liaison between  
41 the school and exchange program agency and as an adviser to exchange students.

The sponsoring individual/organization shall provide evidence to the school that the student will receive adequate financial support for the duration of his/her stay. Exchange students shall not be eligible for free or reduced-price lunches, nor shall schools hold fund-raising events to pay expenses incurred by exchange students.

Privately sponsored exchange students on an F-1 visa may be enrolled if an adult resident of the district has temporary guardianship and the student lives in the home of that guardian. Exchange students on an F-1 visa are required to pay tuition at the established district rate. F-1 visa student admission is limited to secondary schools and attendance may not exceed twelve (12) months.<sup>2</sup>
