1 Within the first three weeks of each school year, the school system will notify parent(s) of students and  
2 eligible students\* of each student's privacy rights. For students enrolling after the above period, this  
3 information will be given to the student's parent(s) or the eligible student at the time of enrollment.<sup>1</sup>  
4 The notice will include the right of the student's parent(s) or the eligible student to:

6 1. Inspect and review the student's education records;
- 7  
8 2. Seek correction of items in the record which are believed to be inaccurate, misleading or in  
9 violation of the student's rights, including the right to a hearing upon request;
- 10  
11 3. File a complaint with the appropriate state or federal officials when the school system violates  
12 laws and regulations relative to student records;
- 13  
14 4. Obtain a copy of this policy and a copy of such educational records;
- 15  
16 5. Exercise control over other people's access to the records, except when prior written consent is  
17 given, or under circumstances as provided by law or regulations, or where the school system  
18 has designated certain information as "directory information." Parent(s) of students or eligible  
19 students have two weeks after notification to advise the school system in writing of items they  
20 designate not to be used as directory information. The records custodian will mark the ap-  
21 propriate student records for which directory information is to be limited, and this designation  
22 will remain in effect until it is modified by the written direction of the student's parent(s) or the  
23 eligible student.

## 24 25 **DIRECTORY INFORMATION**

27 "Directory Information" relating to a student includes the following: name, address, telephone listing,  
28 date and place of birth, major field of study, participation in officially recognized activities and sports,  
29 weight and height of members of athletic teams, dates of attendance, degrees and awards received and  
30 the most recent or previous educational agency or institution attended by the student.<sup>2</sup>

32 Student directory information for 11th and 12th graders shall be made available upon request to persons  
33 or groups which make students aware of occupational and educational options, including official recruit-  
34 ing representatives of the military forces of the State and the United States.<sup>3</sup>

36 \*The student becomes an "eligible student" when he/she reaches age 18 or enrolls in a post-secondary  
37 school, at which time all of the above rights become the student's rights.<sup>4</sup>
