PUBLIC COMMENTS

Juliet Safier spoke on behalf of the VEA. The teachers are extremely frustrated with this budget. They have lost 11 teachers since the 2008-09 school year and each year it gets worse. The answer our budget shortfall seems to be to get rid of teachers. They are requesting an independent audit of the district budget.

Amy Cieloha stated her concerns about decisions made at a board meeting and then what actually takes place once a decision has been made. She referenced the middle school sports program as well as the Band program. She stressed follow through on all decisions that are made. Dr. Cox commented that last year it was discussed to reduce middle school athletics however this was added back into the budget. Only head coaches are being paid with the exception of track due to high student numbers. He has not yet received reports from the middle/high school office on fees collected for band and sports pay to play. He will address this at the next meeting. Jim Krahn indicated that it was suggested using volunteer referees and umpires but the district never agreed to implement this.
