WGS: Aaron Miller had nothing to add to his written report.

VHS: Nate Underwood mentioned that in addition to the band placing 1st at state Jacob Medearis placed 5<sup>th</sup> in the state solo competition. Also, he wanted to mention that even though the teacher who over the last couple of years put together the remedial reading class is leaving, it is imperative to keep this rolling. As of today 100% of the senior class has passed the state reading test!

Financial Report: Dawn Plews stated that she is keeping an eye on the ending fund balance. FINANCIAL REPORT 6.3 There were no questions from the board.

Project Manager Report: Steve Effros reported. 6.4

PROJECT MANAGER REPORT

- On site Construction: The commissioning agents are very impressed with the contractor that installed the mechanical systems. Our building will have one of the most unique sustainable systems in the country. It was suggested that the District put together a living document on how all the systems work.
- Road Improvements: the road work has transitioned from utility installation to ODOT road improvement.
- Wetlands contractors are getting irrigation in place and installing trees in the next
- Compliance currently working on getting the remaining \$2 million from the state. He will help with the final close out work with FEMA.
- On June 1 there will be a large volunteer effort to finish the landscaping around the building. Boora is planning the event and hosting a BBQ provided for the volunteers and contractors as well. The Board is invited to attend.
- He is still working on the Oregon Dept of Energy grant.

#### Special Education Report: James Brookins reported. 6.5

Continuing to increase the life skills population. We have had a lot of move-ins.

- The program also has many transitioning students and continuing needs in the young children pre-school age.
- He is excited about the new life skills classroom at the new school. Students will be helped with cooking, cleaning and public transportation issues.
- Current caseload is a 88
- Compliments were given to the SpEd staff.
- Shared in the excitement of the final senior student passing the state reading test
- SpEd department was 100% compliant this year with one minor mistake.
- SpEd staff did a nice job at the recent in-service held for teachers
- Continuing to expand the use of technology i.e. bookshare.org gives students access

to over 150,000 titles. Computers can read these books for students and student growth is being seen.

## **6.6 Title I Report:** Aaron Miller reported.

- Complimented his staff. The report provided was put together by the Title I reading teacher. They all do a great job helping students make progress in reading and then transfer those reading skills to other areas in the classroom.
- Services include providing reading blocks by ability level. They try to flood grade levels with all staff and create as smallest student teacher ratios as possible.
- Progress is tracked a couple of ways. Kids are making progress but he still feels the need to find ways to enhance the progress and see it sooner.
- Title I funding looks like it will be bumped up a little bit next year which is good news

# 6.7 Healthy Teens Survey Report: DeAnna Pearl reported.

- A hand out was given.
- Perception from reality gap has narrowed substantially.
- Increased perception of risk for alcohol and marijuana in both MS and HS.
- April 2012 Oregon Healthy Teens Survey was recently done. This survey will measure bully intervention and training She is hoping to see more things go up.
- Summer Meals Program will be happening this summer. A \$5,000 grant has been received.

Bill Langmaid stated his concerns about the increase in victimization and harmful behavior as noted on the report.

# 6.8 CLASS Grant Project Report: Juliet Safier reported last month but had some updates.

- Tomorrow hopefully they will know if they have grant approval for next year.
- Evaluation committee has looked at a variety of areas and will be able to see where they are on the scale.
- They have been meeting every two weeks for the last few months and have a first draft ready to go.
- Next year teachers on committee will be invited to be on a pilot committee and discuss their own evaluation. They will reevaluate themselves in January.
- Next year Juliet will be the project manager and Doran Lower will be the communication specialist. There will be a PBIS coordinator as well. Jan dyer will be talking with staff on PBIS.

Greg Kintz commented that the teacher effectiveness with 4 levels of evaluation is recommended to have by the state.

Dawn Plews asked how the classified job descriptions were coming? These are very complex and they are still working on them.
