- Potential for additional funding to reduce school debt
- Ability to create more of a niche with our Sustainability Program above and beyond our standard educational model.
- Allows more flexibility is working with community members to help support apprenticeship programs and instruct in non-core courses. Core courses must still be taught by highly qualified teachers.

## Ouestions from the Board:

- Is there still start-up money for Charter Schools available at the Federal level? Greg was told by OSBA that there is not.
- One building in the District must remain a public school. We would still have Mist Elementary as a public school. Will there be an issue not having a public middle or high school?
- Does becoming a Charter School change requirements for standardized testing at ODE? No.
- Does a Charter School have a separate Board? Yes, although some school board members can be
- Does the Met Group feel our chances for donations might increase if changing to a Charter School is made?

Public Awareness: Mr. Miller has discussed the Charter School idea with the Board, Scott Laird, and the Union Representatives. Scott will be drafting an article to go out to the public. The VEA Leadership is initially on board however they expressed concerns about the District keeping all contractual obligations, Community members will be invited to join in a task force to begin discussions and sharing of information to the public. Names were mentioned of possible participants who are vested in the community to be on the task force. Brett Costley volunteered to be the board representative on this committee.
