The program would offer exposure to students in French before entering High School.

SPECIAL EDUCATION REPORT:

Elaine Lee submitted the Special Education dated July 12, 2012. **PA-10-111 for High School Reform**: attendance regulations have been revised for 7th and 8th grades. The objective is to reflect the necessity of attending classes in order to successfully complete courses.

SPECIAL EDUCATION **REPORT CONTINUED:**

Alternative 6TH through 12TH Grade Program: Dr. Lee and Nancy Vitale, EASTCONN Consultant, continue to work on development of curriculum for the alternative program Transportation: Special Education transportation will be traveling during the summer to Northeast Regional Academy in Putnam and Joshua Center in Danielson; Special Education Enrollment: PreK-8th Grade: 30 special education students in grades PreK3 through 8th. Two 3-year olds students will be transferring from the Birth to Three program to the Voluntown Pre-School Program this fall; Special Education Enrollment: High School: 5 special education students enrolled in Griswold High School and 2 special education student at Norwich Free Academy. There was review of out-placed students, Virtual Learning Academy, Staffing and Professional Development.

PRINCIPAL REPORT:

Alicia Dawe submitted the Principal report dated July 12, 2012 that highlighted activities to implement Board of Education goals for curriculum/instruction/learning, building grounds and community and public relations.

SUPERINTENDENT'S **REPORT:**

Superintendent Burrows explained there is a need to replace the Stairway from Voluntown School to Constitution Field. The stairway would provide access to the field for possible emergency purposes as well as the many school activities held in Constitution field. A special thank you is extended to the Town Maintenance Department for mowing the school grounds on Wednesday, July 11th, 2012.

COMMITTEE REPORTS: Local Prevention Council (LPC): It was announced that Voluntown is the recipient of a Youth Services grant for \$14,000 from the State of Connecticut. In order to receive this grant our local community must come up with \$14,000 in matching funds or donated "inkind" services. Superintendent Burrows indicated \$7,000 will be received from the Town and \$7,000 will be provided through in-kind services from the School and community to meet requirements of the grant; Tools for Schools: Maintenance Updates: summertime custodians are in the process of cleaning the entire school, gym floor was refinished, Science Lab received new counter tops, new hot water heater was installed, oil tank was topped-off, school front office was carpeted, waiting to hear from DBS regarding solar panels, climbing wall to be installed in mid-July, Five-Year Maintenance Plan is on track, and school library re-organization begins the week of July 17 2012; Committee **Assignments 12/13:** reviewed 1st draft of the 2012-2013 assignments for 2012/2013 Voluntown Board of Education Curriculum and Related Committees; Teacher Evaluation: There was review of the PEAC (Performance Evaluation Advisory Council - Connecticut Guidelines for Educator Evaluation) summarizing core requirements to comply with state legislature for the evaluation of educators; Board Self-Evaluation: There was a 2nd reading of the 2011-2012 Board of Education Self-Evaluation.
