The Junior High Dance was held March 14th. A bag pipe assembly was held March 19th and a parent held a small assembly to teach students about bag pipes. Attended Anti-Defamation League Training and students in Grades 6-8 participated in the 1.5 hour Anti-bullying training.

<u>Curriculum, Learning, and Instruction</u>: VES Weekly Notes continue to be sent to faculty members; Team Meetings are continuing to be held; Teacher Evaluation process continues; Common Core State Standards (CCSS) coaches are continuing to work on modules and attend training; attended Out-of District Workshops on School Readiness Council, NELMS 33rd Annual Conference, and EAM District Facilitator Training; and hosted EASTCONN's Principal's PK-8 Consortium.

SPECIAL EDUCATION REPORT

<u>Special Education Population</u> The population is now at (46) in the elementary school building showing an increase of (2). There are presently (4) students in the process of evaluation. The High School special education population is currently at (6) = (1) student in NFA and (5) students in Griswold High School. In addition, there are (7) students presently out-placed. The combined locations show a total of (59) students presently receiving special education services.

<u>504 Populations</u>: There are now twenty-nine (29) students receiving 504 services; (25) in the elementary building and (4) attending highs School.
