Jo-Anne Weir made the second. *The motion was approved*. It was noted this project was completed on time and well under the projected total cost of \$1,104,304.

Paul Ricard made the motion that State Project No. 147-0018 RR for replacing 43,320 square feet of the total 60,165 square feet the Voluntown Elementary School Roof has been completed and authorized the Superintendent of Schools to submit the final ED049 report to the State Department of Education. Barbara Gileau made the second.

A discussion followed and Paul Ricard expressed appreciation for the excellent work of Danny Young and Quality Roofing Services; the guidance of Al Jacunski, Architect for the project, and the overall work of the Building Committee in completing this project.

The motion was approved.

Other: It was noted that as of this time all of the work of this committee has been completed and the only reason for a meeting in the future would be based on the need to complete any unanticipated agenda items.
