- Our 10,000 gallon oil tank will receive a required "tightness testing" and this was performed by Service Station Equipment and these results will be submitted to DEEP to comply with older tank regulations.
- A 2-15-17 report by "UST Compliance Inspection Checklist" from the Connecticut Department of Energy and Environment Storage Tank Protection Unit.
- He also shared a letter from the Connecticut Department of Energy and Environmental Protection stating an "Underground Storage Tank Violation" which will be resolved by providing a completed registration through EZ-File for the facility and all unregistered UST systems,
