  - Miss Braidyn Rainey presented a petition to the Board, as a representative of the West Jefferson High School students. The petition requested the School Board let school out two days early for Christmas vacation, starting Monday, December 22, 2014. Miss Rainey cited that additional minutes, over what the State requires, are built into the school schedule. Miss Rainey answered questions from the School Board. The importance of schools using all the days

wisely leading up to holiday break was discussed. Additional days are built into the school calendar to comply with the risk for bad weather. Complying with State Department of Education rules on closures creates difficultly for changing the 2014-15 calendar. The Board did not make a proposal or action.

- f. Principal Report :
  - 1. WJHS Principal Mr. Wes Woodward
    - i. Discussed the good things going on at the high school. Accreditation is a big concern right now with many survey's to complete. Some seniors will be required to do credit recovery. We have a student that will have the State Requirements to graduate but will be low on district requirements.
    - ii. Questions:
      - a. Mrs. Jimi Burtenshaw asked about the patron, who parked here at the school and asked a girl if she needed a ride, on Tuesday, December 16, 2014.
        - i. The sheriff's office is investigating.
        - ii. Schools have been warned. (Person is known.)
      - b. Mr. Burt Allen asked about the patron's concern for transcripts being sent out to the student's college and also about how students receive credit for their dual credit courses.
        - i. Transcripts were sent out to the colleges by the counseling department and a duplicate was sent by the office. Both met the deadline.
        - ii. Dual Credit comes through the university.

#### 2. Terreton Jr High Principal - Mrs. Camille Cureton

i. Discussed the issues of F's and D's in grades 7-8. There were 37 F's at end of first trimester. She presented a break down to the board. She discussed what is being done and the reasoning behind the fee of \$50 for credit recovery. She believes it is making a difference, comparing 57 F's and D's a year ago to 37 this year. Of the 37 students with F's only 6 had a D or F in Math only.
