I. CALL TO ORDER

II. ADOPTION OF THE AGENDA

III. WORK SESSION AGENDA

a. Bond Priorities

b. 2015-2016 Calendar

c. Jr. High Athletic policy

Mr. Cory Hall addressed the board on the need for some modification on the Athletic Eligibility Policy for Jr. High. He proposed ways the policy could be modified. Mr. Dwight Richins will write up a proposal for the February school board meeting.

1. Discussion was brought up on a cut policy for sports. There is a concern for having so many kids kept too long on teams. This concern was for sports from junior high to high school.

d. Revise Activity Fee

Principal of West Jefferson High School, Mr. Wes Woodward was here to inform the board of the high school budget and the need of fees. He suggested we stay with the \$75 dollar Athletic Fee, but look into giving a break on the 3rd sport as well as for multiple athletes in a family. He also emphasized that no students are getting turned away due to being unable to pay. We have in place a way for students to play.

The board discussed how the hay fundraiser could be better organized so that every farmer is notified and has an opportunity to donate. Many are not asked. The board felt students could be more involved in the hay fund raiser by talking to the farmers.

e. Comp Time Policy

Mr. Dwight Richins expressed concern for the excessive amount of comp time employees are collecting. We are very understaffed which complicates things greatly. Mr. Dwight Richins asked the board to consider hiring another maintenance person to assist with this issue as well as work on projects that will be done if the bond passes.

f. Leadership Policy

Mr. Wes Woodard addressed the high school position on the leadership awards for teachers. He explained the rubric the schools are using. He took questions from the board. Over all, the board is good with both elementary and high school rubrics. The board suggested that it be tracked carefully and teachers understand the process and expectations so there will be no surprises.

g. Athletic Scheduling

The board asked that Mr. Dwight Richins bring an updated athletic schedule for 2015-2016 to the February school board meeting. The board would like to be involved in approving the schedule. Mr. Dwight Richins explained that he has given the Athletic Director and Principal the following direction and advice on the new schedule.

- 1. Trying to keep Girls and Boys Basketball games off of same night
- 2. Use more Saturdays
- 3. Keeping game distance as close as possible (especially C-Teams when playing a lone games)
