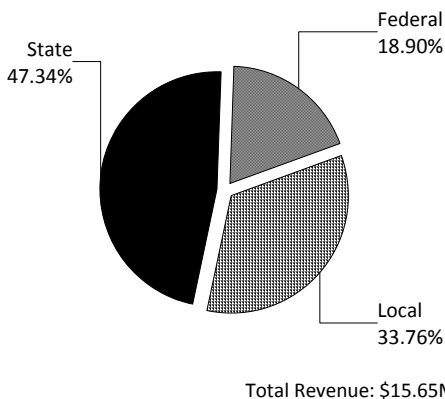

Revenue Sources



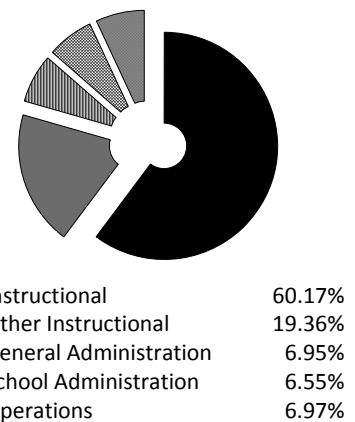
