2. Applications for School Choice will be accepted by the Superintendent of Schools. **All blank spaces must be completed on the application form.** The application/information return deadline is February 26, 2016. Applications should be addressed to:

4. Students will be selected on a random basis by a lottery process pursuant to Massachusetts General Law, Chapter 76, Section 12B, Paragraph J.
5. Students accepted are subject to all policies and regulations of Ludlow Public Schools.
